

TERMS AND CONDITIONS GOVERNING PARTICIPATION IN KBC PLAY ALONG GAME

A. CONTEST DESCRIPTION:

"KBC Play Along Game" is a skill and knowledge based online quiz game which is being hosted and can be played on the SonyLIV app which is owned by Sony Pictures Networks India Private Limited (formerly known as Culver Max Entertainment Private Limited).

B. DEFINITIONS:

For the purposes of the Terms and Conditions, the expressions used as shown herein-under shall have the meaning ascribed to them as shown herein-below:

- a. **"Company" or "SPNI"** means Sony Pictures Networks India Private Limited.
- b. **"Contestant(s)"** means the participants who have been selected to participate in the Fastest Finger First (FFF) round in the current season of the Show.
- c. **"Daily Quiz"** means the quiz that will be live on the App every day from Monday to Sunday consisting of 5 (five) questions worth 100 points each. A new quiz will be live every day. Each PAP (defined below) can answer the quiz only once in a day and the PAP will get 30 seconds to answer each question.
- d. **"Episode"** means an episode of the Show (as defined below);
- e. **"Episode Prize"** means the daily gratification prizes that will be awarded to the Episode Winners under the gratification categories defined by the Company.
- f. **"Episode Winner(s)"** means top PAPs who have scored the highest points for a PAG for any Episode of the show (or part thereof).
- g. **"Fastest-Finger First/FFF"** means that part of the Show where one question is asked to the selected Contestant(s) who in turn shall answer the same. The first Contestant to correctly answer the question in the least time shall be entitled to proceed to the Hot Seat as the Hot Seat Contestant.
- h. **"Grand Prize or Play Along Special Week"** means the prize that will be awarded to the Grand Prize Winner as may be announced by the Company from time to time on PAG;
- i. **"Grand Prize Winner(s)"** means such number of the shortlisted PAP(s) as may be selected from and amongst the PAPs who have played the PAG anytime during the period starting from 10th August 2026 to 25th December 2026 and filled the registration form on or before 10th August 2026. The Grand Prize Winners are eligible for the Grand Prize.
- j. **"Hot Seat Contestant(s)"** means the winning Contestant of the Fastest Finger First round and who occupies the Hot Seat before the host of the Show to participate further in Show.
- k. **"Har Din Lakhpati"** means the top 05 PAP who has scored the highest points for a PAG for any Episode (as decided by the Company) of the Show (or part thereof). This Top 05 Daily Player is eligible to win INR 1 Lakh as per the schedule decided by the Company.
- l. **"Jaldi 5 Buzzer Round or Jaldi 5"** means that part of the Show wherein the top 2 winning Contestants from the FFF round will be asked Questions by the host of the Show and the Contestant who answers the first 5 Questions correctly shall be selected as the Hot Seat Contestant for the Episode.
- m. **"KBC Play Along Game" or "Play Along Game" or "PAG"** means the general knowledge based online quiz titled "KBC Play Along Game" which will be played by the PAP (defined below) in accordance with the Terms and Conditions on SonyLIV from Monday to Friday of a particular week starting 10th August 2026. A new quiz will be available to play on the App each day which the PAP can play and earn additional points.
- n. **"Play Along Participant(s)" or "PAP"** means any person(s) who registers and / or participates in the PAG via the App (defined below) and who (i) is above eighteen (18) years of age as on 10th August 2026; (ii) is a citizen of India and residing in India, save and except the Restricted States or restricted otherwise as per this Terms and Conditions (iii) is of sound mind and health and (iv) agrees to enter into and participate in the PAG in accordance with the Terms and Conditions as defined in this document.

- o. **"Show"** means the television series titled **"*Kaun Banega Crorepati – Season 18*"** ("**KBC**") produced by SPNI and telecasted on its channel Sony Entertainment Television ("**SET**") and on SonyLIV.
- p. **"SonyLIV" or "App"** means the OTT platform accessible as an application and through web, owned and operated by the Company where the PAG will be hosted.
- q. **"Stipulated Time"** for the purposes of the PAG shall mean either (i) the period until which the Company permits a PAP to answer any question forming part of the PAG; or (ii) the time taken by the Hot Seat Contestant to answer the question; whichever is lesser, subject to a minimum of 15 (fifteen) seconds.
- r. **"50 -50 Lifeline"**: On using this option for a particular question, the gaming system will delete 2 incorrect options out of 4 leaving the PAP with only 2 options to select the correct answer.
- s. **"Terms and Conditions"** means these Terms and Conditions governing the PAG, as stated here in in entirety and as may be amended by the Company from time to time.
- t. **"Third Party Sponsor"** means a person or an entity who may sponsor a gratification or drive a quiz, as part of the PAG.
- u. **"Winners"** shall mean either the Episode Winner(s) or the Grand Prize Winner(s) or any other winner as may be determined by the Company in terms of the Terms and Conditions.

C. ELIGIBILITY CRITERIA

In order to participate in the PAG, all the following conditions need to be fulfilled:

- individuals should have registered and / or participated in the PAG via the App; and
- should be above eighteen (18) years of age as on 10th August 2026
- Should be a citizen of India and should be residing in India, save and except the Restricted States or restricted otherwise as per this Terms and Conditions.
- Should be of sound mind and health; and
- such individual agrees to enter into and participate in the PAG in accordance with the Terms and Conditions as defined in this document.

D. PROCEDURE TO PARTICIPATE IN THE PLAY ALONG GAME:

1. Participation

- a) Eligible PAPs should participate in the PAG by registering on the SonyLIV App in the KBC Play Along Game (PAG) section. The PAG will be available on the App as per the following schedule:

- c) The above-mentioned schedule could be added to, modified or cancelled based on programming/ technical requirements of the Company or in the event the Show is for any reason rescheduled, extended, cancelled or terminated early, at the sole discretion of the Company.
- d) The mobile number from which the registration is received will be used to identify the PAP as a unique identification number. We urge PAPs to use numbers where they would be clearly identified as the PAP of the PAG.
- e) Any entry for participation in the PAG is not transferable.
- f) The PAP may be required to furnish necessary supporting documentation as proof of age, address, name, photo identity and nationality i.e. one original and attested photocopies of

- either (i) passport/driving license or (ii) PAN Card along with birth certificate and ration card or (iii) voter identity card with birth certificate (iv) UID/Aadhar Card.
- g) The Company has the right at any time to require proof of identity and/or eligibility. The failure to provide proof or affidavit of eligibility, including the proof of name, address and correct date of birth within the time as stipulated in the Terms and Conditions or within the timelines as requested by the Company may result in disqualification. The Company also reserves the right to disqualify a PAP in case where a discrepancy is found to exist in the information furnished/provided/stated by the PAP during the conversation with the Company or any of the Company's authorized personnel, sub-contractors and vendors in the PAG, and/or in the information stated in the documents furnished by the PAP or at any time.
 - h) The Company may, at its discretion, contact the PAP(s), if required, for any clarifications needed for the information provided when contacted by the Company.
 - i) All personal details and information requested by and supplied to the Company by each PAP must be truthful, accurate and in no way misleading. The Company reserves the right to disqualify any PAP(s) from the PAG at its sole discretion or in a scenario should the PAP(s) at any stage supply untruthful, inaccurate or misleading personal details and/or information.

2. Steps for Registration

- a) Download the SonyLIV App from the application store. Please note, the application download is free of cost, however data charges may apply. For further details please contact your telecom operator. Alternatively, you can open the SonyLIV mobile website on your mobile browser to access the PAG. Please note, the PAG is not accessible via browsers on your PC or laptops or any other device.
- b) If you are a first-time user, then you will be prompted to register by providing your mobile number and/or e-mail id. An OTP will be sent across to your mobile number and/or email address to verify the same.
- c) Once registered, you will be prompted to provide your basic details such as Date of Birth, Gender and State/City etc.
- d) Click on "KBC Play Along" banner/ Access "KBC Play Along" from the menu.
- e) Select Language Preference (English/ Hindi).
- f) Click on the "Play Now" tab.
- g) Answer Profile related questions including occupation and education related questions.
- h) The PAP has to log in the PAG using their social media accounts i.e. Google account and Facebook. The Company hereby clarifies that any linking of social media accounts hereunder (i.e. Google account and Facebook) is being done for verification purposes to ensure that the person playing/accessing the PAG is 18 years and above and is not a robot. In the event the PAP uses a SIM card not registered in her/his name for registration, the Company will not be responsible to track such PAP and such PAP will be disqualified.
- i) In the event, it is not possible to determine with certainty the person who registered from a particular mobile number, that entry would be disqualified. PAP(s) are requested to use mobile numbers which are unique to them and is registered on such PAP(s) name only.
- j) The procedures for registration and participation in the PAG are subject to the Terms and Conditions stated herein. Non-conformance by any PAP(s) to the Terms and Conditions will disqualify him/her from participation or winnings, immediately, as the case may be.

3. Charges for the PAG

- a) The SonyLIV application download and participation in the Play Along Game are free of cost, however data charges may apply. For further details please contact your telecom operator.
- b) Please check with your telecom operator for any other applicable charges. In case any user registers while roaming in a different circle/zone/country, additional roaming rates may apply. Please contact your telecom operator for the applicable rates.
- c) There is no levy of an entry fee for participation in the PAG. Any person who claims to be from the Company and asks the PAP for paying an entry fee for participation in the PAG or states that the Show or the Company is distributing any lotteries or cash prizes, is defrauding the PAP(s) and he/she should report this to the local police immediately. There

are also no lotteries, prize monies, cash prizes etc. distributed by the Company or the Show. The only way to participate in the Show and win the prizes is in the manner detailed hereunder.

4. **Playing Rules**

4.1. **Individual Players**

- a) During each Episode of the Show, the PAP will have to answer questions as displayed on the App within the Stipulated Time.
- b) The Stipulated Time varies for each question. PAP(s) should ensure that they appraise themselves of the same before each question.
- c) For every question answered correctly, the PAP will be awarded points (as per the points’ tree shown in PAG).

- d) PAPs will get 200 additional points for answering the questions within 10 seconds.
- e) In addition to the daily questions, PAPs will have the opportunity to answer certain bonus questions asked during the gameplay and earn additional points of 1000/500/100 points.
- f) PAPs will also have the opportunity to win additional 50-50 Lifelines by taking certain actions as mentioned and directed in the PAG section.
- g) PAPs would also be eligible to get one 50-50 Lifeline during gameplay for each Episode. This feature will become active only for questions where the total timer is more than 45 seconds.
- h) Lifelines available to the Hot Seat Contestants on screen during the Show are not available to the PAP(s) in the PAG.
- i) The ‘Super Sawaal’ question will not be applicable in PAG and the points for the same will not be included in PAG winner selection.
- j) In the “JALDI 5” segment, Q1 to Q5 will be assigned the points as per the points tree (mentioned above in point c) and each question asked succeeding first five will be assigned 250 points.
- k) SPNI can change these points and add/discontinue such point winning activities or questions as it deems fit. No claims will be entertained regarding the same.

4.2. An on-going PAP could lose the opportunity to play one or more questions, in any of the following scenarios:

- i. Where a PAP answers message / etc. on the device where he/she is playing PAG or watching a video on the PAG;

- ii. Where a PAP exits the App during the course of playing the PAG or starts to watch a video on the App;
- iii. Where there is a network drop or battery drain-out in the course of playing the PAG or watching a video on the PAG;
- iv. Where the device on which PAG is being played hangs during the course of playing the PAG or watching a video on the PAG;
- v. Where the PAG or the ability of a PAP to play the PAG is affected by any other network / IT / phone issues. Where a PAP exits the PAG in the middle of a session when a Hot Seat Contestant is answering questions, the PAP will be permitted to rejoin the PAG only when the next question is asked.

4.3. Points scored by PAP across multiple days/ played along will get accumulated. In the event a PAG is terminated mid-session for any reasons whatsoever, the PAP will have to wait till the next question is asked on the Show, in order to continue scoring points.

4.4. Once the “Submit” button has been pressed, the PAP will not be allowed to change the answer. If the "Submit" button does not disappear, the server has not received the response and the PAP would be required to press the button again. Please note that the PAP has to select the answer option and press the button within the Stipulated Time.

4.5. Post submission (locking) of the answer, the PAP(s) will not be permitted to modify / alter / change the answer submitted.

4.6. Only the answers received within the Stipulated Time will be considered valid.

4.7. The Company will not entertain any claims / questions / queries with respect to the authenticity or correctness of any questions and answers for the questions asked in any round of the PAG.

4.8. The Company’s decision on the correctness or incorrectness of any answer is final and binding on all PAPs.

4.9 The PAG activity is intended to operate as a short-term engagement aligned to a defined operational period and shall remain in effect until then, unless otherwise extended in writing by the Company. Notwithstanding the foregoing, the Company reserves the sole and absolute right to suspend, modify, curtail, or terminate the PAG activity, in whole or in part, at any time and for any reason, as it may deem appropriate in its discretion, without incurring any liability or obligation arising from such action.

5. Episode Winner(s) Selection

- a) The Company shall select the top “05” PAPs with the highest number of points for the particular Episode for each episode as the Episode Winner. It is hereby clarified that the scores used for selection the Episode Winners from among the KBC PAPs shall include scores of the PAG quiz for that episode. Episode Winner may win following Prize during the entire season of the Show consisting of (i) Har Din Lakhpatri Prize of Rs. 1,00,000 (Rupees One Lakh) (ii) Daily Prize of Rs. 100 (Rupees One Hundred) (iii) Daily Prize of Rs. 10,000 (Rupees Ten Thousand) (iv) Weekly Prize of Rs. 10,00,000 (Rupees Ten Lakhs)
- b) Winner of Har Din Lakhpatri Prize of Rs. 1,00,000 (Rupees One Lakh) is not eligible to win other prizes (i) Har Din Lakhpatri (ii) Daily Prize of Rs. 100 (Rupees Hundred) (iii) Daily Prize of Rs. 10,000 (Rupees Ten Thousand) within the same week and also the coming weeks. The Winner shall be eligible to the Weekly Prize of ₹10,00,000 (Rupees Ten Lakhs), but he will not be eligible to win ₹10,00,000 (Rupees Ten Lakhs) in the week Har Din Lakhpatri Prize. The participant shall not be eligible to win the Grand Prize.
- c) The Company, at its sole discretion, can also apply region-based filters for the shortlisting of winners in order to provide a more balanced distribution of winners.
- d) A user with the same name/email-id/date of birth/city/state participating through multiple mobile numbers will be treated as the same user for the purpose of any gratification and will be disbursed only one Episode Prize.

- e) The Company shall have the sole discretion to modify the number of Episode Winners per prize category and the Episode Winners hereby undertake not to question or to make any claims against the same.
- f) The Episode Winners will need to ensure that their mobile numbers and/or other contact details are correctly updated in order to claim this gratification. The Episode Winners can claim the gratification latest by 31 January 2027, following which the unclaimed gratification will lapse.
- g) Any payments being made to the Episode Winners hereunder are being done through third party payment platforms and at all times shall be subject to the terms and conditions of the said third-party platforms. The Company shall in no manner be responsible for any failure on the part of such third-party payment gateway to make payments to the Episode Winner. Further, the Company shall not be responsible in any manner whatsoever for any errors, omissions or failures on the part of the e-wallets where such prizes and/ or gratifications are being transferred. The PAP hereby undertakes that he/she shall not raise any claims against the Company in this regard and shall keep the Company indemnified to that extent.
- h) The Company reserves the right to replace the Episode Winner if (i) it finds any duplication in the contact details submitted by the Winner, (ii) it has reasonable grounds to suspect that the Episode Winner has not verified his identity to the satisfaction of the Company (iii) for any other reason that the Company may deem necessary.
- i) The Company shall have the sole discretion to decide whether or not to declare the Episode Winners or the manner in which the Episode Winners are announced, and the Episode Winners hereby undertake not to question or to make any claims against the manner in which the names of the Episode Winners are declared by the Company. The Company may also at its sole discretion decide to change the Episode Prize.
- j) The Episode Winner determination will be on the basis of the total points earned by PAPs while playing the PAG for that particular Episode. The PAPs who (i) is not previously an Episode Winner and (ii) have scored the highest number of points in the PAG for one Episode of the Show will become eligible for being chosen as the Episode Winner.
- k) For the sake of clarity, PAPs who have won gratification and/ or prizes in any of the previous seasons of KBC or Kon Honaar Crorepati (KHC) are eligible to win in this season also. There are no restrictions on winning gratification and/ or prizes in the consecutive seasons of KBC.
- l) Once an eligible PAP has been an Episode Winner, he/ she is ineligible to be selected as the Episode Winner for the same category in the entire season. However, the participant who are winners of Rupees One Hundred Daily Prize shall still be eligible to win the Grand Prize.
- m) The Company and/or its authorized agents, affiliates and representatives will rely upon only such information as may be provided by the Episode Winner at the time of participation in the PAG (or registration on the App). The PAPs are hereby required to keep their information updated.
- n) Winners should also note that TDS maybe deducted as applicable on gratifications of INR 10,000 (Indian Rupees Ten Thousand only) and more and further documentation (such as PAN card of the winner and certain additional details / documentation) might be sought in order to process the payments of the prize. Should the Episode Winners fail to provide such additional documentation or fail to provide the same within the time period specified by the Company or and in the form and manner in which it is requested by the Company, then the Company might be unable to remit the prize amount to such Episode Winners and the Company shall in no manner be liable for the same.
- o) SonyLIV identifies users through their unique registered phone numbers. Hence, in the event of sharing login ID/ password, multiple logins, multiple registrations through your registered phone number, loss of registered phone number or other such instances, the Company will send winning prizes / vouchers / coupons / etc. to the PAG profile through which the game was played and won the prize and/ or gratification.

6. **Har Din Lakhpati**

- a) The Company shall select the Top 5 PAP with the highest number of points for the particular Episode as the 'Har Din Lakhpati' Winner. It is hereby clarified that the cumulative scores of the PAPs earned in a particular Episode's PAG will be used for the winner selection. Each eligible PAP could win cash gratification of INR 100,000 (subject to applicable taxes). However, such PAP can win cash gratification of INR 100,000 only once during the entire season of the show. The Top 05 winners will receive a message, the following day (before the next episode airs on television) to confirm their details. In case, the PAPs do not or is unable

- to confirm their details, the Company has the right to choose the following PAPs with the highest score.
- b) The 5 PAPs who have won “Har Din Lakhpati” gratification and/ or prizes in the previous seasons of KBC are not eligible to win in this season. However, they can win any other gratification and/ or prizes.
 - c) The Company, at its sole discretion, can also apply other criteria to select ‘Har Din Lakhpati’ Winner including but not limited to region-based filters for the shortlisting of eligible winners in order to provide a more balanced distribution of winners.
 - d) A user with the same name/ email id/ date of birth/ city/ state participating through multiple mobile numbers will be treated as the same user for the purpose of any gratification and will be disbursed only one Episode Prize.
 - e) The Company shall have the sole discretion to modify the number of “Har Din Lakhpati” Winners and the “Har Din Lakhpati” Winners hereby undertake not to question or to make any claims against the same.
 - f) The “Har Din Lakhpati” Winners shall receive a Email/SMS/WhatsApp Message from the Company to (i) verify the details of the Winner provided at the time of registration (ii) provide details regarding document submission and verification. The “Har Din Lakhpati” Winners will have to submit their Passport size color photo, Aadhar and PAN card documents along with a cancelled check within the stipulated timelines by emailing the documents on kbcresponse@setindia.com in order to claim the Prize.
 - g) The “Har Din Lakhpati” Winners will need to ensure that their name, address and mobile numbers and/or other contact details are correctly updated on the documents in order to claim this gratification. The Company reserves the right to forfeit the Episode Prize of a particular Winner if it finds any duplication in the contact details submitted by the Winner and/or if Winner has not verified his identity to the satisfaction of the Company. The “Har Din Lakhpati” Winners can claim the gratification on or after 17th August 2026. The last date to claim the gratification will be 31 January 2027, following which the unclaimed gratification will lapse. The Company shall have the sole right to modify the schedule for claiming the gratification.
 - h) The Company shall have the sole discretion to decide whether or not to declare the “Har Din Lakhpati” Winners or the manner in which the “Har Din Lakhpati” Winners are announced, and the “Har Din Lakhpati” Winners hereby undertake not to question or to make any claims against the manner in which the names of the “Har Din Lakhpati” Winners are declared by the Company. The Company may also at its sole discretion decide to change the “Har Din Lakhpati” gratification.
 - i) The “Har Din Lakhpati” Winner determination will be on the basis of the total points earned by any 5 PAPs while playing the PAG for that particular Episode. The PAPs who (i) is not previously a “Har Din Lakhpati” Winner and (ii) have scored the highest number of points in the PAG for one Episode of the Show will become eligible for being chosen as the Winner.
 - j) For the sake of clarity, PAPs who have won gratification and/ or prizes in any of the previous seasons of KBC or Kon Honaar Crorepati (KHC) are eligible to win in this season also. There are no restrictions on winning gratification and/ or prizes in the consecutive seasons of KBC.
 - k) Once an eligible PAP has been a “Har Din Lakhpati” Winner, he/she shall be ineligible to be selected as a winner “Har Din Lakhpati” or Rs. 100 (Rupees One Hundred) or Rs. 10,000 (Rupees Ten Thousand) again during the entire Season and shall further be ineligible to win the Weekly Prize in the week in which he/she is declared a “Har Din Lakhpati” Winner. However, the participant shall not be eligible to win the Weekly Prize in the same or Grand Prize. The participant shall not be eligible to win the Grand Prize.
 - l) The Company and/or its authorized agents, affiliates and representatives will rely upon only such information as may be provided by the “Har Din Lakhpati” Winner at the time of participation in the PAG (or registration on the App). The PAPs are hereby required to keep their information updated.
 - m) PAPs should note that as per government regulations, a) The Company shall deduct applicable taxes (TDS) as per prevailing government regulations. b) Ensure the change is reflected across the draft where ever applicable taxes on the prize of INR 1,00,000 and gratify the remaining balance amount to the “Har Din Lakhpati” Winner(s). b) The Company, at its sole discretion, can also apply other criteria to select ‘Weekly Prize’ Winner including but not limited to region-based filters for the shortlisting of eligible winners in order to provide a more balanced distribution of winners.

For the purposes of winning the gratifications, the final Top 05 “Har din Lakhpati” PAP declared on the PAG by the Company, post the Episode, shall be considered as the final “Har din Lakhpati” Winner for that particular Episode. This is subject to the Top 01 “Har din Lakhpati” PAP adhering and complying with any and all additional information and requirements that may be specified by the Company from time to time. The Leader Board is indicative and the Leader Board data cannot be used as evidence in any manner.
- b) The selection of the Top 05 PAP further depends upon the completeness of their profiles. The Company will use the full name and location of the Top 05 PAP as available to the Company on the login profiles created by them during registration, to display the same during the episodes. In the event, any PAP so selected have not updated their details for the Company to use or the profile name provided is not suitable for broadcast (such decision shall be at the Company’s discretion), then the Company shall have the sole discretion to disqualify such PAP. The Company shall also have the right to replace such disqualified PAP with the next highest scorer on the Leader Board.
- c) The Company may also decide to display a subset of the overall Leaderboard which will show the region/city wise top PAPs.
- d) The Company may also decide to separately display the leaderboard of certain Third-Party Sponsor driven quizzes from time to time as it deems fit.

11. Daily Quizzes

- a) The Company at its sole discretion may run multiple daily quizzes on the App.
- b) The Quizzes will be made live on the App on all weekdays and weekends, during the current season of the Show.
- c) The Quizzes will consist of 5 (five) questions worth 100 points each. Each PAP can answer the quiz/5 questions only once a day (as per the time period mentioned above). The PAP will get 30 seconds to answer each question.

12. Daily Bonus Question/Question of the Day

- a) The Company will also ask two bonus questions per episode and a question of the day which if answered correctly by the PAP shall make them eligible for certain extra points.
- b) The PAP(s) will be awarded an additional 500 and 100 points respectively for answering the Daily Bonus Questions correctly. The PAP(s) will be awarded an additional 1000 points for answering the Question of the Day correctly.
- c) The points earned by correctly answering the bonus question shall also be added to the PAP’s overall leaderboard score for that Episode’s PAG.

13. Grand Prize Winner Selection

- a) Any PAP who has attempted at least one question, has scored 10,000 points or more in the PAG, has successfully filled the profile related questions asked during the Registration process on or before 10th August 2026 and plays the Play Along Game in accordance with the Terms and Conditions is eligible to be shortlisted for the Grand Prize winner determination. The cutoff criteria of 10,000 points in the PAG is subject to change at the discretion of the Company. The Grand Prize and the eligibility thereof are specified in the below table.
- b) All PAPs who have filled the form and the profile questions updated in the KBC registration section within the defined timelines (10th August 2026 to 25th December 2026) are eligible to be shortlisted for the following prize (“Grand Prize”):

The eligible PAPs will be shortlisted on a pre-defined reservation criteria as defined by SPNI, and approximately 1,000 PAPs (basis the highest score and randomizer) will be selected to attend the on-ground auditions as auditionees for the Play Along Special Week. The Company reserves the right to shortlist additional back-up PAPs for the auditions as per requirement.

Note: The above shortlisting criteria for the Play Along Special Week may be modified based on the Company's discretion as they deem fit.

- c) Once a mobile number is chosen and confirmed for audition, it will not be chosen the second time. The Company reserves the right to alter/reduce/increase the number of PAPs (and the selection criteria thereafter) that will be selected to attend the audition as auditionees, at its sole discretion.
- d) The audition, audition evaluation and shortlisting of participants as Hot Seat contestants for the KBC Play Along Users have been detailed in Annexure 1. The shortlisted PAP(s) who have been selected to participate in the to play Fastest Finger First round of Play Along Special Week shall be eligible to play for that particular week. However, in case of any special episodes or in case of cancellation of a particular episode for that week, the PAP(s) will not be eligible to play for such days as decided by SPNI at their sole discretion.
- e) The details of the Grand Prize will be intimated to such Grand Prize Winner(s) by the Company on the mobile number provided by such PAP(s) at the time of registration for the PAG;
- f) The Company reserves the rights to determine and/or announce the timelines and the methodology of determining Grand Prize Winners from time to time.
- g) Participant who has not been declared a winner of the “Har Din Lakhpati” Prize or the “Weekly Prize” of INR 10,00,000 (Rupees Ten Lakhs) may be considered for inclusion in the contestant pool for the KBC Play Along Week, subject to the applicable eligibility criteria and selection process.
- h) Upon being selected for the “Har Din Lakhpati” Prize and/or the “Weekly Prize” of INR 10,00,000 for the relevant Promotion Period. The contestant shall not be eligible or be considered for KBC - Play Along Week.

14. Winner Declaration and Pay-out/ Prize handover

Every Episode may not have prizes and/ or gratifications.
- b) The Company reserves the right to offer or withdraw any of the prizes and/ or gratifications as provided herein, at any point of time, including after they have been announced and the Company shall not entertain any queries in this regard from the PAPs.
- c) The Company shall have the liberty but not the obligation to publish information with respect to the top points scored by the PAPs in the PAG conducted from time to time (“Leader Board”).

The Leader Board is indicative only and may not be up to date across all PAPs and the Leader Board data cannot be used as evidence in any manner. Due to high participation volume, server load, software malfunction, etc., point calculation may not be immediately correct. In the event point calculations are incorrect, the Company will correct the same in due course. This could result in changes to PAPs points. The Company will have no obligation to intimate any PAP in the event scores are corrected.

- d) The Company may, in its sole discretion, exclude a PAP from participating in any part of the PAG which may include without limitation (i) circumstances which, in the Company's view, renders the PAP unfit to participate therein; (ii) inability to produce documentation specified by the Company proving the identity of the PAP; (iii) any other reason that, at the discretion of Company, would adversely impact the Company or the PAG. At no point of time will the Company be obliged to notify unsuccessful PAPs of its decision.
- e) Company will use the number used to register on the App by the PAP to identify the Winner of the prizes and/ or gratifications won, if any. Inability on the part of the PAP to accordingly show or provide the required identification proof could entitle the Company to disqualify the PAP from any winnings, if any.

- m) The Winner hereby agrees that the Winner shall not hold the Company responsible for any delays and/ or disputes and/or claims arising out of any Episode Prize that such Winner may be entitled to and shall keep the Company indemnified against any and all such claims.
- n) The Episode Winners hereby agree that any in case of any disputes/ claims arising out of the Episode Prize, the same shall be addressed directly to the sponsor of the Episode Prize and the Company shall not be held responsible for the same.
- o) The Company may refuse to pay winnings or reclaim all sums paid to Winners in the event of any fraud, dishonesty or non-entitlement on the part of any of such Winner(s) to participate in the PAG under the Terms and Conditions as well as delay/refusal to submit documents on time.

The PAP can continue to answer questions once reconnected to the central PAG game server(s). Company or its vendors and partners are not responsible for any such instances.

- m) In case any unauthorized activity is observed on the PAG, that particular PAP will be disqualified to play till such time as the Company deems fit. The Company would not be responsible in any manner whatsoever on account of such disqualification.
- n) Company shall not be liable for any failure of the application server or system in the course of playing the PAG.
- o) The Company shall endeavor to make all reasonably practicable arrangements, it cannot guarantee or assure seamless connectivity or continuous availability of the application, server, system or software to the PAPs during the conduct of the PAG as these are dependent on external utilities/ service providers and factors which could be beyond control of the Company.

The PAP(s) shall ensure that the photos or videos submitted by them in any public domain, or their performances shall not be obscene, vulgar, defaming, denigrating women or children, hurting religious sentiments, depicting violence or shall not infringe the rights of a third person. The PAP(s) shall solely remain liable for any action (criminal/civil) arising therefrom.

- f) The PAP(s) hereby agree and acknowledge that the collection and processing of the Personal Data by the Company is for a lawful purpose and is necessary for facilitating their participation in the PAG. The Personal Data shared by the PAP(s) shall be retained by the Company till the Winners are declared and the promotions with respect to the Winners are completed.

- 1) The PAPs (i) who have participated in the PAG during the period commencing from 10th August 2026 to 25th December 2026 (ii) who have answered minimum one question of the PAG and (iii) scored a minimum of 10,000 points cumulatively between 10th August 2026 and 25th December 2026 will be considered and shortlisted through a randomizer on the basis of a pre-defined reservation criteria as mentioned

hereinbelow. Approximately 1,000 PAPs (basis the highest score and randomizer) will be selected to participate in the Ground Audition as Auditionees. Once a mobile number is chosen and confirmed for Ground Audition, it will not be chosen the second time.

- 2) The 1,000 selected Auditionees will be selected and contacted basis the above-mentioned criteria using a pre-defined selection criteria on reasonable endeavors basis. The following selection grid will be used:

- 3) In the event, there are less than the required number of Registrants for a particular cell in the reservation grid above, then the same will be filled-up from the remaining Registrants.
- 4) Any PAP who has been shortlisted for the ground or online audition rounds of the current season; or made it once to the Fastest Finger First of the current season of the Show or to the hot seat of any of the previous seasons of the Show, he/she will not be eligible to participate in this segment of the current season of the Show.
- 5) The selected Auditionees for the Ground Auditions will be reached-back through an Email/SMS/WhatsApp on the number used for registration as per the details available with the Company from 10th August 2026 to 25th December 2026 [Note: Timelines are subject to change based on degree of participation, technical issues, force majeure reasons, etc.]
- 6) The Email/SMS/WhatsApp Message flow will be as follows:

The Company shall not be held liable for telephone system difficulties, downtime of systems, back-up of data, telephone system capacity and other technical impediments during the registration process.

The Company shall not be responsible and/or liable in any manner whatsoever in case the Auditionee(s) is unable to participate in the audition process due to failure in delivery of the confirmatory Email/SMS/WhatsApp Message.

The Company at its sole discretion may decide to conduct the callouts manually through Email/SMS/WhatsApp Message at any given time as they deem fit.

7. The Audition for selecting the Contestants participating in the FFF rounds will be conducted on _____. The audition dates are subject to change as per the Company's discretion. The timings for registration of Auditionees will be intimated and cannot be changed or modified to suit Auditionee's requirements.
8. The Auditionees will have to be present at the allotted Audition venue on the date and time allotted to such respective Auditionees along with the documents and photographs required (both in original and attested photocopy).
9. Late entrants may stand disqualified from the Audition process at the discretion of Company. Each Auditionee will be provided a unique registration number, which Auditionee must always carry with him/her while at the Audition. The Auditionees will have to sign the registration form along with the release form and any other documents as required by the Company to participate in the Auditions. Company's authorized representatives will have the final right to refuse registration/eligibility at their sole discretion.
10. Subject to completion of formalities as prescribed by Company, the Auditionees will have to first go through a written GK test. The Auditionee will need to carry the original document and 2 attested photocopies of each document. All the above-mentioned documents must be in English or Hindi only.

(Submission of the aforesaid documents/photos of the Auditionee does not imply that the Auditionee has been selected for further participation in any manner whatsoever.)

12. All Auditionees shall maintain the decorum of the Audition venue and shall abide by the Terms and Conditions thereof. Further the instructions of the Company shall be adhered to strictly. Any Auditionee who acts in contravention to the instructions of the Company or creates nuisance either to the Company or to any other person, shall immediately be disqualified from participating in the Audition and the Show and shall be asked to leave the Audition venue.
13. The decision of the Company in connection with the Audition including but not limited to short listing the Auditionees will be final & binding and is non-contestable. In case of any dispute or difference in respect of this Audition, the decision of the Company shall be final and binding on all concerned.
14. The auditions can be moved to an online platform to abide by the Central or State Government issued guidelines or regulations related to Covid-19 pandemic. In such cases, the Company will not be liable to reimburse any travel and accommodation expenses.
15. The Company reserves the right to amend the audition process for select auditionees at its sole discretion or conduct online personal interviews (PI) as they deem fit of the auditionees who could not attend the ground auditions for any reason.
16. A two-member jury will evaluate the shortlisted Auditionees on the basis of the answer sheets and the recorded footages of the Video Audition of the Auditionees. Shortlisted Auditionees from this evaluation round will be evaluated by the 2nd evaluation jury.

17. The 2nd evaluation shall be performed by a 03 (three) member jury i.e., one representative each from the Company and an independent member (“**Judges**”). The Judges will select the Participants based on the answer sheets and recorded footage of the Video Audition of the Auditionees. Two lists of Participants will be selected for the Fastest Finger First round, out of which one list of Participants will be used for replacement purposes.
18. Two lists of Participants will be selected for the Fastest Finger First round, out of which one list of Participants will be used for replacement purposes. Also, 1 Auditionee will be shortlisted from Mumbai (based on performance evaluation score) as “stand-by” in order to replace any confirmed shortlisted Auditionee who is a “no-show” on the day of the shoot.
19. Based on Company’s requirement and creative discretion, the final selection of Contestants for Fastest Finger First of the Show will be made from amongst the shortlisted pool of Auditionees.
20. The representatives of the Company (“Representatives”) will notify the selected Auditionees of their selection for the Fastest Finger First round and ask for confirmation of their details (name, gender, date of birth and address), after which the Representatives will inform the selected Auditionees of the shoot date and documentation requirements, based on finalized shooting schedules. The Participant is requested to carry a valid English/Hindi photo Identity proof and 3 passport size color photographs of the Participant(s) to the Studio for the shoot. In case of non-availability of Participant or of his/her supporting documentation, further participation will not be permitted.
21. For the Shoot, the Company may cluster the shortlisted Contestants based on creative requirements of the Show. No questions / queries will be entertained based on the same. The Company reserves the right to alter or modify the cluster without providing any reasons / justifications for the same to any person or PAP(s). For further clarity, the Company at its own discretion reserves the right to increase/decrease the number of shortlisted Contestants in a particular cluster based on creative requirements of the Show.
22. Upon confirmation by the selected Auditionee of his/her availability for the Fastest Finger First round, he/she shall qualify for the said round.
23. The Participant will be permitted to bring along one companion for the shoot of the Episode. The Participant(s) and his/her respective companion will travel at their own risk.
The Company shall be responsible for the travel (shortest route possible) and hotel stay arrangements of the Participant(s) and one companion who have confirmed attendance with the Company. The travel and stay arrangements will be made as per the Company’s discretion and any request in this regard by the Participants shall not be entertained. However, in case of Participant(s) residing in Mumbai the Company shall not be responsible for making any accommodation arrangements.
24. The Participant(s) who have been selected to play Fastest Finger First round in a particular Episode of the Play Along Special Week shall be eligible to play for that week’s episode. However, in case of any special episodes or in case of cancellation of a particular episode for that week, the Participant(s) will not be eligible to play for such days as decided by the Company at their sole discretion.
25. All Participant(s) agree to conform to and accept the terms and conditions stated herein along with any Terms and Conditions which may govern the Show.
26. Contestant(s) will not be confirmed as Contestants for the Show if they are suffering from any Covid19 symptoms or any kind of ill health, medical problems (viz.: heart ailment, blood pressure ailment, final stages of pregnancy, etc.). It is the responsibility of the Contestant(s) to be medically fit for participation. Nevertheless, the final decision regarding their participation in the Studio Part of the Show rests entirely with the Company. If the Contestant suffers from any medical condition or is diagnosed with any medical conditions during the shoot of the Show, such that the Contestant will be unable to shoot of the Show any further or his/her presence on the sets might put the others on the sets at risk of contracting the same medical conditions/issues, then the Company may choose to cancel such Contestants participation, at whatever stage the same might be. Should the Contestant not be completely fit to travel, it is hereby advised that the Contestant inform the Company of the same. The Company may advice such Contestant not to travel and the Contestant may stand eliminated/disqualified at the discretion of the Company.

27. If the Company has reasons to believe that the Contestant shows any symptoms of having contracted COVID -19 or any other communicable infections/diseases, then the Company shall have, in its sole discretion, the right to cancel their participation, at any given stage and the Contestant hereby agrees not to make any claims in this regard. The Company shall at no time be responsible for any medical expenses of the Contestant and/or their companions, either during or after the shoot. The Contestant hereby undertakes to keep the Company promptly inform in the event he/she is feeling unwell or has any symptoms of having contracted COVID-19 virus. Any delay or failure on part of the Contestant to inform the Company of his/her symptoms can lead to disqualification.
28. The Contestant hereby undertakes to adhere to all health and safety guidelines issued by the Company. The Contestant shall ensure that the Contestant follows and abides by all the instructions given by the Company with respect to the shoot of the Show including but not limited to all instructions issued by the Company or any production house designated by the Company with respect to the curbing the spread of the COVID -19 virus or any other epidemic/ pandemic declared by the relevant authority. The Company reserves the right to terminate the participation of any Contestant at any stage in the event the Contestant fails to follow any instructions of the Company with respect to the Show.
29. The Company may require the Contestant to sign an undertaking or declaration any other similar documents prior to them attending the shoot, with regard to their participation. The Contestant hereby agrees to sign all such documents that may be required by the Company and any refusal by the Contestant to sign such documents shall give Company the right to disqualify such Contestant.
30. The Contestant hereby undertakes that in the event, he/she is unable to reach at the designated time slot/date for shoot or is unable to participate for the Fastest Finger First round of the Show on the given date due to any reasons, including any Central or State Government issued guidelines or regulations, any disruption in travel etc, the Company shall not be liable to conduct the audition or the reschedule the shoot for such Contestant and the Contestant may stand eliminated/disqualified at the discretion of the Company.
31. The Contestant shall be responsible for compliance with Covid19 or any other disease related guidelines issued by the Central/State Government or any concerned authority for himself/herself and/or their companions. The Participant and/or their companions are advised to always abide by the advisories issued by the Government with respect to social distancing and wearing masks for their own safety and for the safety of the other around them. It is advisable that should the facility be easily available in your hometown, you take a COVID test prior to travelling for auditions.
32. The Contestant acknowledges that no insurance is required for the purpose of participation on the Show. The Contestant acknowledges that should the Contestant and/or their companion fall ill during the course of travel or on/before/after their arrival in Mumbai for the shoot, or during or after the shoot, the Company shall not be responsible for the same. It is hereby clarified that the Company shall not be bearing any hospital or medical expenses of the Contestant and/or their companion.
33. The Contestant and/or their companion shall not hold the Company responsible, at any time and in any manner whatsoever, for any reason whatsoever regarding the process, policy or any protocols to be followed during the audition process and/or the shoot. The decision of the Company shall be final in all regard with respect to any aspect of the Show.
34. The Contestant and/or their companion agree that by choosing to travel to Mumbai and participating in the Show, they are doing so at their own risk, and agree to release the Company, to the maximum extent allowed by law, from any liability, direct or indirect, connected to or resulting from any Covid19 connected illness that may be suffered by the Contestant and/or their companion.
35. These Terms and Conditions and the PAG shall be governed by and construed in accordance with the laws of India and the PAP(s) submit irrevocably to the jurisdiction of the Courts in Mumbai

36. The Company reserves the right to amend (add, delete or modify) the Terms and Conditions prospectively or retrospectively, at its discretion and without prior notice, in order to improve the PAG or remedy any issues that occur.
37. The Company has the right at any time to terminate the PAG without any prior intimation or notice to the public and also the Company is not obligated in any manner whatsoever to compensate any person or persons who have participated in the PAG.
38. The Company is empowered to take a decision on any case not covered by the present Terms and Conditions.
39. The Terms and Conditions have been originally written in English and translated in Hindi. In case of any conflict in the interpretation of the clauses between the Hindi and English rules and regulation, the interpretation of the Terms and Conditions in English shall prevail.
