## Terms and Conditions for "RKFC Spin the Ball" Contest

The following terms and conditions ("T&Cs"/ "Terms and Conditions") shall be applicable to contest being conducted by Culver Max Entertainment Private Limited (formerly known as Sony Pictures Networks India Private Limited), ("Company" or "CMEPL"), relating to its series "Real Kashmir Football Club" to be streamed on its digital platform, "Sony LIV" ("Platform") which shall function in a manner as specified in this T&C ("Contest")

CMEPL shall collection, storage, use, disclosure, transfer of Personal Data in compliance with all applicable laws including the Digital Personal Data Protection Act, 2023. The Participants hereby agree and acknowledge that the collection, storage, use, disclosure, transfer, of the Personal Data by CMEPL is for a lawful purpose and is necessary for facilitating your participation in the Contest. The term 'Personal Data' shall mean and include the name, contact information, residential address or other details pertaining to the identity of the Participants/Winners and other information as may be required for the purposes of disbursement of the Prize(s). CMEPL including its divisions, affiliates and subsidiaries, and their respective agents and representatives, employees shall not be responsible for any loss of Entries for any reason whatsoever including, due to any technical problems for Entries received after the deadline as a consequence of computer service delays, interruptions, electronic failures or overloads, or for lost, misdirected or misplaced Entries or any lost, late or misdirected computer transmission or network, electronic failures of any kind or any failure to receive entries owing to transmission failures or due to any technical reasons.
