The Company reserves the right to modify these Rules and Regulations without any prior notice. You are advised to access, view and keep themselves informed of these Rules and Regulations. If you do not agree with any of the Rules and any amendments thereto, you must not participate in Contest.

A. PROCEDURE TO PARTICIPATE IN THE SHOW

Registration Process

- 1) Registrant's are required to register for the Contest on Sony LIV May 26, 2025, 09:00:00 PM onwards until the start of the Contest (including the day of the ground Contest).
- 2) The Registrant can register:
 - a. via scanning the QR code (in the manner capture below) displayed by the Company along with the promotional messages through its official handle on various social media platforms (Instagram, Facebook, YouTube, SonyLIV etc.).
 - b. at the venue on the day of the Contest (in the manner capture below).
- 3) Participants can access the QR code and participate by following the flow defined below:
 - a. Scan the QR code. The scanned QR code will direct the Registrant to the registration form on SonyLIV app.
 - b. Select Language (English/ Hindi)
 - c. Read the Rules & Regulations.
 - d. Enter name, Date of Birth (DOB), Gender, mobile number, alternate mobile number and email id of the Registrant
 - e. Enter State, city and district to capture area of residence
 - f. Enter full name of Parent/ Legal Guardian of the Registrant
 - g. Enter relationship of the Parent/ Legal Guardian with the Registrant
 - h. Enter occupation of the Registrant 's Parent/ Legal Guardian
 - i. Have you participated in any dance reality show/talent show previously? If yes, please mention the show name.
 - j. Are you currently under any existing contract with any company/production house/channel etc. that restricts you from participating in Super Dancer Chapter 5? If yes, please mention the details below.
 - k. Have you been formally trained in Dance?
 - I. Which is you preferred style of dancing?
 - m. Registrant's may upload a dancing video if they want; however, this is not mandatory.
 - 4) Registrants who have pre-registered as per 2(a) in the manner as mentioned flow are not required to register again at the Ground Contest and they may attend the Ground Contest

at any one venue of their choice on the designated date, at their own convenience subject to availability. Registrants who have registered on the day and venue of the Ground Contest as per the flow hereinabove will, submit the required documents and immediately proceed with the Ground Contest process on the same day and at the same venue subject to submission of the required documents.

5) To be eligible for Ground Contest round, it is mandatory for all Registrants to complete the registration on Sony LIV App and submit the required documents. Registrants whose complete registration data and documents is not received by the Company for any reason whatsoever as on the date of the Ground Contest will not be permitted to appear for Ground Contest.

Ground Contest Process

- 1) The Registrants who completed their registration on the App and whose complete data has been received by the Company will be eligible to proceed further as Participant(s).
- 2) The Ground Contest for selecting the Shortlisted Participants will be conducted as per the schedule below:

Note - The Ground Contest dates are subject to change as per the Company's discretion. The timings for registration of Participants will be intimated and cannot be changed or modified to suit Participant's requirements.

- 3) The Registrants and their Parent/Guardian are required to be present at the designated venue on the specified date and time provided by the Company, they must also bring the necessary documents and photographs (both original and attested photocopies). The Company may decide to change these timings at its sole discretion.
 - Note: Travel, accommodation, and all other expenses in relation to the participation of the Registrant and/or Participant and/or Shortlisted Participant will be at the Parent/Guardian and/or Registrants' own costs and only the Registrant and/or Participant and/or Shortlisted Participant along with the Parent/Guardian will be permitted to enter the Contest venue upon submission of the above-mentioned documents and photographs.
- 4) Late entrants may stand disqualified from the Contest process at the discretion of Company. Each Participant after completing Registration will be provided a unique registration number, which Participant must always carry with him/her while at the Contest. The Parent/Guardian of the Registrant will have to sign the registration form along with the release form and any other documents as required by the Company to participate in the Contests. Company's authorized representatives will have the final right to refuse registration/eligibility at their sole discretion.

5) Parent/Guardian of the Registrants are required to see below the requirement of the documents for verification ("**Documents**") if selected as a Shortlisted Participant:

For enabling the Registrant to participate in the Show, the Registrant or Parent/Legal Guardian of the Participant, shall bring the photocopies along with the originals of the following documents of the Registrant at the Ground Contest venue as proof of identity, age, and residence, wherein such photocopies and originals should be clear and legible:

- a. For valid name proof of the Registrant (s) (any of the following)
 - i. Birth Certificate
 - ii. Aadhar Card
 - iii. Passport
- b. For valid age proof of the Registrant (s) (any one of the following)
 - i. Passport
 - ii. Birth Certificate
 - iii. School Certificate
 - iv. Court Affidavit
- c. For valid address proof of the Parent and/ or Legal Guardian (s) (any one of the following)
 - i. Passport
 - ii. Ration Card of the Parent or Legal Guardian
 - iii. Aadhar Card
 - iv. Landline Phone Bill/ Electricity Bill
 - v. Driver's License
 - vi Voter ID
- d. For valid Proof of relationship/guardianship (any one of the following)
 - i. Ration Card
 - ii. Passport
 - iii. School leaving certificate
 - iv. Court order declaring the Guardian as the legal guardian of the Registrant
 - v. Any other Govt. document establishing the relationship/guardianship

(Submission of the aforesaid documents does not imply that the Registrant has been selected for further participation in any part of the Ground Contest and/or the Show. Failure to provide the required documents in the required format at the Ground Contest venue will result in disqualification of the Registrant from further participation. No claims will be entertained regarding the same by the Company.)

6) In case, the Registrant is a Non-Resident Indian (NRI) then the Parent/Guardian of the Registrant will be additionally required to furnish proof of citizenship either through submission of Indian passport or birth certificate and furnish necessary documentations and permits to work in India as per the laws of India.

(Submission of the aforesaid documents does not imply that the Registrant has been selected for further participation in the Ground Contest or any part of the Show)

- 7) Documents provided should be clear and readable and any failure to provide the same can lead to disqualification. The Company reserves the right to disqualify any Registrants from the Ground Contest, in its sole discretion, if the Company is not satisfied with the documents submitted by the Registrant(s) or the Registrant(s) at any stage is unable to supply any of the documents required by the Company or the Registrant(s) supplies unclear, inaccurate, incomplete, or misleading personal details and/or information. Successful verification of the documents is mandatory for the Registrants to progress further to the Ground Contest round. The Company reserves the right to ask the Parent/Legal Guardian of the Registrant(s) to re-submit any of the above-mentioned document proof at any stage of the Ground Contest.
- 8) If Registrants have been selected as Shortlisted Participant, then Parent/ Legal Guardian(s) of the Shortlisted Participants are required to adhere to the verification process of the Company at the designated location which includes bringing original copies of their Documents for age proof, residence proof and their nationality proof. Additionally, the Shortlisted Participants (s) and/or Parent/Legal Guardians shall be required to provide the Company and/or the Producer requisite documentation i.e., original copy of passport, birth certificate or Aadhar Card, etc. Successful verification of the Documents is mandatory for the Shortlisted Participants. The Company reserves the right to ask the Shortlisted Participant to re-submit any of the above-mentioned document proof any stage of the Show.
- 9) The shortlisting process followed for the Show comprises of 2 (two) Qualifier Rounds viz. Registration and Ground Contest. The Participant(s) will be judged on the basis of his/her dancing skill and talent to qualify for each consequent level. The Participant (s) shall be evaluated by a panel comprising of representatives of the Company and/or experts from the dance domain appointed and finalized by the Company and/or the Channel at its sole discretion ("Panel"). It is further clarified that, the Participant during the Qualifier Rounds shall be judged based on predefined evaluation parameters such as skill, talent, personality and life story and/or any other criteria as set out by the Panel and/or the Company.
- 10) The Shortlisted Participants selected for the Show by participating in the above-mentioned Qualifier Rounds will stand a chance to showcase their dancing skills in one of the Episodes of the Show. However, the Shortlisted Participants will not be eligible to compete (i) with the Top 12 Contestants selected to participate in the Gala Round and any further rounds of the Show (ii) for the prize offered to the Winner of the Show.
- 11) If the Registrant(s) fails to complete or attend the Ground Contest as per the schedule provided by the Company for any reason whatsoever, the entry of the Registrant(s) will be invalid, and such Registrant(s) shall be disqualified. No disputes in this regard will be entertained.
- 12) The Company shall approximately select between 1 to 5 Shortlisted Participants (s) participating in the Show from amongst the Participant (s) selected through Ground Contests (As per the discretion of the Company). The Company's shortlisting will be as

per their sole discretion and no disputes regarding the same will be entertained.

B. Representations & Warranties of the Parent/Legal Guardian:

- 1) The Parent or Legal Guardian of the Registrant participating in the Ground Contest hereby represents and confirms that such Parent or Legal Guardian completely understands the nature of Ground Contest and Show and that he/she has voluntarily chosen at his/her free will to permit the Registrant to participate in the Ground Contest and further participate in the Show (if selected) and such Parent/Legal Guardian of the Registrant(s) is willing to bear all risks, costs & consequences arising from participation of the Registrant in the Ground Contest and/or the Show. All representations and warranties, obligations, terms and covenants as laid down herein and applicable to the Registrant shall be deemed to be applicable on the Parent/ Legal Guardian and the Parent/Legal Guardian of the Registrant(s) hereby agrees to comply and abide by the same.
- 2) It is expressly required that a Parent or Legal Guardian accompany the Registrant to the Ground Contest. The Parent or Legal Guardian shall remain present for the full duration of the Ground Contest and shall be solely responsible for the Registrant's supervision, conduct, and well-being during their interaction with the Panel. The Company shall not be held liable for any issues arising from a Registrant being unaccompanied or inadequately supervised.
- 3) The Parent/Legal Guardian of the Registrant(s) hereby agrees and acknowledges that it shall be such Parent's/ Legal Guardian's complete responsibility to ensure that the Registrant's school/ college / university/ institute's attendance and education is not affected due to his/ her Minor child's participation in the Ground Contest and/or Show (if selected). The Parent/Legal Guardian of the Registrant(s) hereby undertakes to be fully responsible towards Registrant's education and shall ensure that the Registrant's education & welfare will not be affected in any manner while permitting him/her to participate in the Ground Contests and/or Show (if selected).
- 4) The Parent/Legal Guardian of the Registrant(s) hereby agrees and confirms that even if the Registrant is selected for the Show through the Ground Contest, neither the Registrant not the Parent/Legal Guardian of the Registrant(s) shall have any right to claim any benefit/demand/consideration/monies from the Company or the Show Management, in addition and/or in exchange of the selection in the Show and/or the Ground Contest.
- 5) Any incomplete, erroneous, or unclear information, shall be considered invalid and deemed null and void and the entry of such Registrant will not be considered.
- 6) By participating in the Registration and Ground Contest process, it is deemed that the Parent/Legal Guardian of the Registrant(s) have read, understood, accepted and agreed to abide with all the Rules & Regulations of Registration and Ground Contest as mentioned herein and is unconditionally bound by the terms of use and privacy rules of the Program as uploaded on the App, any decisions made by the Show Management in

its sole discretion, including any interpretations of the Rules & Regulations.

- 7) In the event of any technical errors, the Company and/or Producer shall not be responsible for the same. Further, Entries received despite or owing to any technical errors shall be considered invalid and the Company shall have the sole discretion in such cases.
- 8) The process by which the Shortlisted Participants are informed of their selection will be updated by the Company by the way of updating these Rules and Regulations or as per their sole discretion. The Registrants are advised to regularly access, view and keep themselves informed of these Rules and Regulations.
- 9) It is a condition of entry and participation in the Ground Contest that the Parent/ Legal Guardian on behalf of the Registrant, make themselves and Registrant(s) available to participate in the Ground Contest, agree and sign up with the Registrant Release and Authorization Form and any other documents as requested by the Company/Producer and abide by Rules & Regulations of such Registrant Release and Authorization Form and the Rules, Regulations for the Show and/or Ground Contest as devised from time to time by the Company including but not by way of limitation of these Rules & Regulations.
- 10) The Parent/Legal Guardian of the Registrant(s) hereby represent and warrant that Registrant(s) is not under any disability (mental, physical or legal disability that can prevent the Registrant for participating in subsequent process, selection process or the Show), restriction, or any kind of prohibition, which shall prevent Registrant from performing or adhering to any of the Rules and Regulations herein and have not entered into and shall not enter into any agreement that may violate the Rules and Regulations herein.
- 11) If at any point in time during the Ground Contest, and/or the Show (if selected), it comes to the Company's knowledge that the Registrant has become medically/mentally/ physically unfit to continue with the participation in the Ground Contest and/or the Show, then the Company or the Show Management reserves all the rights to disqualify /eliminate the Registrant from the Ground Contest or Show and/or at any point in time, without any liability to the Registrant and/ or Parent/ Legal Guardian.
- 12) The Company may, at its discretion, contact the Parent/Legal Guardian of the Registrant(s), if required, for any clarifications needed for the information provided in the registration.
- 13) In case there is any mismatch of Registrant(s) details submitted for the Ground Contest, the Registrant(s) may be disqualified from further participation in the Ground Contest and/or Show, if Parent/Legal Guardian of the Registrant(s) is unable to resolve discrepancies.
- 14) All personal details and information requested by and supplied to the Company by each Registrant must be truthful, accurate and in no way misleading. The Company reserves the right to disqualify any Registrant(s) from the Show or Ground Contest in its sole

- discretion, should the Parent/Legal Guardian of the Registrant(s) at any stage supply untruthful, inaccurate or misleading personal details and/or information.
- 15) By registering for the Show, the Parent/Legal Guardian of the Registrant(s), represents that the Registrant(s) is medically fit and do not have present or past psychological ailments. If in the past, Registrant(s) has had any psychological ailments or have been under medication for any psychological anxiety, hypertension, depression or any other medical problems, the same shall be disclosed to the Show Management in writing along with a copy of the certificate from a qualified medical practitioner declaring Registrant(s) to be fit for participation in the Show. In the event the Registrant(s) and/or the Parent/Legal Guardian suffers from any medical conditions during the shoot, then the Show Management, will on a best endeavour basis provide reasonable medical assistance to the said Registrant(s). However, in the event such medical condition renders the Registrant(s) unfit for further shooting/participation in the Show or the Ground Contest, then the Show Management shall have the right to disqualify such Registrant(s) from further participation. If such Registrant(s) has won any prize money before any such disability, then the same shall be paid to the Registrant(s) in accordance to the process communicated by the Show Management.
- 16) For the purpose of participation in Ground Contest and/or the Show, the Parent/Legal Guardian of the Registrant(s) shall be required to sign such additional document as may be directed by the Company. Please note, signing such additional documents shall be mandatory for the Registrant's eligibility to qualify for the Ground Contest. Further, all expenses, if any, including but not limited to travelling, lodging, food and any other incidental costs shall be borne by the Parent/Legal Guardian of the Registrant(s). This clause is applicable to anybody accompanying the Registrant as well.
- 17) Registrant(s) and/or the Parent/Legal Guardian of the Registrant(s) should not carry any weapon, alcohol or drugs of any kind during the Ground Contest, otherwise he/she shall be disqualified from the Show.
- 18) Registrant(s) and the Parent/Legal Guardian of the Registrant(s) is also required to refrain from wearing any clothing items bearing brand name, trademark, designer or sports logos or bearing the names or likeness of a celebrity, living or dead, during the Ground Contest or any subsequent shoot. The Registrant(s) and/or Parent/Legal Guardian of the Registrant(s) is also not permitted to wear or mention any competing TV channel names, competing Shows or names of competitors of sponsors of the Show.
- 19) The Parent/Legal Guardian shall abide by any condition and requirement that organizers require for the purpose of participation by the Registrant including the conditions required as per Guidelines to Regulate the Child Participation in TV Serials, Reality Shows and Advertisements 2010-2011 issued by National Commission for Protection of Child Rights ("NCPCR Guidelines") and the Parent agrees that Producer has briefed the Parent of the nature of the Show. Further, should the Shortlisted Registrant be eligible for any prize monies, the same shall be disbursed in accordance to the NCPCR Guidelines or any similar laws or regulations that may govern the said prize money. The Parent/Legal Guardian hereby undertakes to complete the necessary processes, furnish such

documents and sign such documents that may be required by the Company or any financial institution or agency to disburse the prize money to the Shortlisted Registrant. The Parent/Legal Guardian shall not protest such process laid down by the NCPCR guidelines or any such applicable law

20) By participating in the Ground Contest , the Parent/ Legal Guardian hereby represents that if the Registrant is selected in the Show, the Parent/Legal Guardian will ensure that the Registrant will not Contest for, appear in, or attend the production of any other dance talent / dancing show or enter into any commercial contract with respect to dance with any company during the Term.

C. General rules and regulations

- 1. By choosing to participate in the Ground Contest for the Show or by sending entries in any of the aforesaid manner shall be acceptance of these Rules and Regulations.
- 2. These Rules & Regulations may be subject to amendment from time to time and as such participation in the Ground Contest for the Show would be considered acceptance of the amended Rules & Regulations.
- 3. There is no levy of an entry fee for participation or at any stage in the Ground Contest. The Participant and/or Registrant(s) and or Parent/Legal Guardian of the Participant and/or Registrant(s)t, is not required to pay any amounts, fees or monies at any stage of the Show in any manner or for any reason whatsoever. Any person who claims to be from the Company and asks the Participant and/or Registrant(s) and or Parent/Legal Guardian of the Participant and/or Registrant(s) for paying an entry fee for participation in the Ground Contest for Show or to pay monies for any reasons associated with the Ground Contest for the Show or asking to pay accommodation or other charges that may be reimbursed at a later stage, is defrauding the Participant and/or Registrant (s) and or Parent/Legal Guardian of the Participant and/or Registrant(s) and he/she should report this to the local police immediately. There are also no lotteries, prize monies, cash prizes etc. or any other gratification distributed by the Company or the Show. The only way to participate in the is in the manner detailed above and prize monies (if applicable) are awarded only to the selected Contestants. Any person who claims to be from the Company and offers any lotteries, prize monies, cash prizes etc. to anyone is defrauding the person and he/she should report this to the local police immediately.
- 4. An Entry is not transferable.
- 5. Registration to the Ground Contest for the Show does not guarantee the selection of the Participant and/or Registrant(s) to proceed with the Show. Registration also does not entitle any Participant and/or Registrant(s) to a prize or award. If at any time, including after disbursement of prize, any information submitted on behalf of the Participant and/or Registrant(s) by the Parent/Legal Guardian of the Participant and/or Registrant(s) is found to be incorrect, false, or otherwise misrepresented or

- misleading, the Parent/Legal Guardian of the Participant and/or Registrant(s) shall be liable to refund all amounts received from the Company.
- 6. The Company also reserves the right to disqualify a Participant and/or Registrant in case a discrepancy is found to exist in the information furnished/provided/stated by the Parent/Legal Guardian of the Participant and/or Registrant(s) during the conversation with the Company or any of the Company's sub-contractors and vendors in the Show, and/or the information stated in the documents furnished by the Parent/Legal Guardian of the Participant and/or Registrant(s).
- 7. The Company and/or the Producer and/or Judges and/or Panel of the Ground Contest and the Show reserve the right with respect to the decisions of the selection and/ or the elimination of the Participant and/or Registrant and the selection and/ or the elimination of the same shall be final and binding on all the Participant and/or Registrant(s) and in no event shall the Parent/Legal Guardian of the Participant and/or Registrant(s) dispute such decision(s).
- 8. The Company and/or the Channel reserve the right in its sole and absolute discretion to amend, alter, modify, change, vary or terminate the Ground Contest, Show, format any Rules & Regulations mentioned and accordingly the rules for registration, process of Ground Contest, Participant and/or Registrant(s) eligible for Qualifying Rounds, Rules and Regulations, and/or the Ground Contest for the Show at any time, at its sole discretion, during the Ground Contest Period or otherwise without giving any prior notice to the Parent/Legal Guardian of the Participant and/or Registrant(s) or the Participant and/or Registrant(s) and it shall be the sole responsibility of the Parent/Legal Guardian of the Participant and/or Registrant(s) to check the Rules and Regulations from time to time. The Participant and/or Registrant(s) by participating in the Ground Contest process agrees to such amended rules.
- 9. The Parent/Legal Guardian of the Participant and/or Registrant(s) hereby acknowledges that the Participant and/or Registrant has voluntarily chosen to participate in the Ground Contest for the Show at his / her free-will and with the absolute consent of his/her Parent/Legal Guardian and Parent/Legal Guardian of the Participant and/or Registrant(s) is willing to bear all risk, costs and consequences arising from such participation in the Show. It is a condition of entry and participation in the Ground Contest for the Show that the Participant and/or Registrant(s) and or Parent/Legal Guardian of the Participant and/or Registrant(s) has not entered into any contractual, commercial, sponsorship agreement (including but not limited to recording, performing and/or merchandising contracts) or other arrangement for example with a management company or an individual to act as the Participant and/or Registrant's manager in respect of his/her musical or performing abilities or the products thereof or in respect of his/her name, likeness, image or biography which might be in breach of the Rules & Regulations or otherwise prevent the Participant and/or Registrant(s) from participating in the or the broadcast, promotion, exploitation or sponsorship thereof and should this condition be violated at any stage, the Participant and/or Registrant shall be disqualified. The Company shall have the authority and right to disqualify Participant and/or Registrant's, at any point of time, if

it comes to the Company's knowledge that the Participant and/or Registrant's, being a Minor has participated without the due consent, knowledge and awareness of their Parent /Legal Guardian and/or Participant and/or Registrant(s) is in breach of any Rules and Regulations and/or undertakings herein.

- 10. The Parent/Legal Guardian hereby represents that neither the Participant and/or Registrant nor the Parent/Legal Guardian has not been accused or convicted or is otherwise involved in any criminal offence (including but not limited to acts of moral turpitude and harassment) and/or is not under inquiry or trial by the police or judiciary which has not been disclosed to the Company in writing. That the Participant and/or Registrant(s) and/or the Parent/Legal Guardian is /are not required to be present before any authority including police or any court of law during the shooting dates informed by the Company and has no other disability which would prevent the Participant and/or Registrant(s) participation in the Ground Contest or the Ground Contest for the Show (if selected).
- 11. The Company reserves the right to suspend or disqualify any of the Participant and/or Registrant(s) in case it has reasonable grounds to conclude that the Parent/Legal Guardian the of Participant and/or Registrant have been alleged in any public domain and/or social media websites for any misconduct, sexual harassment, physical abuse, coercion in any form, criminal cases or any other reasons which may tantamount to general misconduct
- 12. The Parent/ Legal Guardian of the Participant and/or Registrant shall ensure that the acts/ performance in the Ground Contest video shall in no manner infringe any rights including the copyright of a third person/party. In the event of any violation to the aforementioned, the Participant and/or Registrant shall be disqualified from the Ground Contest, immediately, without any prior notice of the same and the Parent/ Legal Guardian on behalf of Participant and/or Registrant shall solely be liable for any and all action arising therefrom and shall also be liable to indemnify the Company, its affiliates/group companies/employees, the Producer, agents, representatives, etc. against any and all losses, claims including third party claims, disputes, disruption, demands, actions, damages, liabilities, etc.
- 13. Participant and/or Registrant(s) will not be confirmed as Contestants of the Ground Contest for the Show if they are suffering from any kind of ill health, medical problems (viz.: heart ailment, blood pressure ailment, final stages of pregnancy, COVID-19 etc.). It is the responsibility of the Parent/ Legal Guardian of the Participant and/or Registrant that Participant and/or Registrant is medically fit for participation. Nevertheless, the final decision regarding their participation in the Ground Contest and the actual shoot of the Ground Contest for the Show rests entirely with the Shown Management.
- 14. The Parent/Legal Guardian on behalf of the Participant and/or Registrant hereby undertake to sign any and all such documents, as may be required by the Company to enable the Participant and/or Registrant to participate in the Ground Contest and the Show including but not limited any declarations and undertaking as may be required with respect to the COVID-19 pandemic. During the shoot of the Show and/or during Ground Contest, the Parent/Legal Guardian on behalf of Participant and/or Registrant hereby agrees to abide by all rules, regulations, guidelines, Government orders and any and all instructions issued by the Company with respect to the shoot of the Show.
- 18. The Parent/Legal Guardian hereby confirm that they understand that the process of Ground Contest does not guarantee participation or selection for the show in any manner. Should there be any government rules, regulations, laws, notifications etc. including but not limited to the COVID-19 related SOPs issued by either the Central or the State Government, which would render the participation of the Participant and/or Registrant impossible or should the participation of the Participant and/or Registrant(including but not limited to the Participant and/or Registrant's and/or the Parent /Legal Guardian's ability to travel or be present of the shoot) not be possible or permissible owing to any of Government regulations, rules, procedures, guidelines, laws etc., at any stage of the Show, then the same will lead to disqualification. The Company shall have complete discretion in this regard and the Parent/Legal Guardian hereby undertakes not to dispute the same in any manner.
- 19. If at any time, including after disbursement of prize, any information submitted by the Parent/Legal Guardian on behalf of the Participant and/or Registrant is found to be incorrect, false, or otherwise misrepresented or misleading, the Parent/Legal Guardian on behalf of the Participant and/or Registrant shall be liable to refund all amounts received from the Company.
- 20. The Show

Management does not accept any responsibility for any incorrect and/or incomplete contact detail provided and/or delay in receipt of contact details and/or non-receipt of contact details. The Company or the Show Management shall at its own discretion make or refuse to make additional attempts to contact any Participant and/or Registrant.

- 21. The Show Management reserves the right to record the Contest as part of the selection process and for future reference. However, the Parent/Legal Guardian on behalf of Participant and/or Registrant cannot record the Contest on behalf of the minor Participant and/or Registrant. In the event of any unforeseen loss of recordings, the Company may, at its own discretion, request Contest ees to appear for a repeat Contest session. The Company reserves the right to increase/ decrease/ alter the number of Contest ees at any point.
- 22. The Parent/Legal Guardian on behalf of the Participant and/or Registrant shall at all times keep confidential the selection process and all details regarding the Show including Ground Contest and Personal Interview which he/she might be informed of or which he/she might learn or come to know of as a Participant and/or Registrant(s) or as Parent/Legal Guardian of the Participant and/or Registrant(s) or as a short listed potential candidate. If any Parent/Legal Guardian on behalf of the Participant and/or Registrant is found to indulge in any malpractice or in sharing any information with respect to the Ground Contest & selection process will be disqualified from the Show immediately.
- 23. The decision of the Company in connection with Ground Contest including but not limited to short listing the Registrants and/or Participants will be final & binding and is non-contestable. - 24. - 25. If entries are received for participation in the Ground Contest, it is assumed that the person sending in the entry has provided the Company with permission to send SMS's to him/her or call him / her, whether such sender is registered on the National Do Not Call registry. The Company will only contact the Participant and/or Registrant and / or Parent/Legal Guardian of the Participant and/or Registrant(s) on the mobile number provided by the Parent/Legal Guardian on behalf of the Minor Participant and/or Registrant. The permission to contact shall be valid also for inviting the Participant and/or Registrant to participate in subsequent/future chapters of the Show
- 26. The Company reserves the right, at its sole discretion, to disqualify any Participant and/or Registrant who himself/herself or whose Parent/Legal Guardian or any person related to them, may be responsible or who tampers with the Entry(ies), Ground

Contest process, App, and to cancel, modify or terminate the Ground Contest or any part of the Ground Contest /Show. Further, the Company reserves the right to take legal action against such Participant and/or Registrant/Parent/Legal Guardian/person /party who has committed a breach under the Cyber laws (Information Technology Act, 2000 and all its amendments thereof) and/or any other laws as may be applicable from time to time and the Company shall be entitled to such remedies in law as applicable.

- 27. The Company and its sub contractors shall not be responsible for any delay in receipt or non-receipt or incomplete receipt of the Ground Contest Video / other details of the Participant and/or Registrant. The Company shall not be responsible for any technical difficulties or data corruption that may arise during recording/upload of the Ground Contest Video/content. Further, The Company shall not be responsible and/or liable in any manner whatsoever in case the Participant and/or Registrants and / or Parent/Legal Guardian of the Participant and/or Registrant(s) are unable to register their entry and participate in the Ground Contest due to failure on part of the internet service provider, facility provider, etc.

- 29. - 31. The Company and its affiliates are not responsible for lost, late, illegible, incomplete, invalid, unintelligible, technically corrupted or misdirected videos, which will be disqualified. Show Management shall attempt to use commercially reasonable efforts to ensure the security and accuracy of all videos (provided, however, that the Parent/Legal Guardian of the Participant and/or Registrant acknowledge and agree that such methodologies are not infallible, and that the organizers make no guarantee as to their effectiveness).
- 32. The Parent/Legal Guardian hereby acknowledges and agrees that the relationship between the Parent/Legal Guardian of the minor Participant and/or Registrant, Participant and/or Registrant(s) and the Company is not a confidential, fiduciary, or other special relationship.
- 33. The Rules and Regulations shall be construed and governed in accordance with the laws of India and in case of any dispute or other matter arising shall be referred to a sole arbitrator appointed by CMEPL and shall be governed by the Arbitration and Conciliation Act, 1996, amended from time to time. The venue for arbitration shall be Mumbai. CMEPL shall not be liable for any kind of charges and/or expenses in connection to the Arbitration and it shall be solely borne by the Participant and/or Registrant who has raised the dispute.
- 34. Subject to the provision of above, the Courts having jurisdiction under the provisions of the Arbitration and conciliation Act, 1996, to determine all matters which the court is entitled to determine under the Act, including without limitation, provision of interim relief's under the provisions of Section 9 of the Arbitration and Conciliation Act, 1996, shall exclusively be the courts at Mumbai, India.
- 35. The Company shall not be answerable to any person with regards to any Ground Contest process including but not limited to the, selection or elimination or disqualification of any Participant and/or Registrant etc.
- 36. The Rules & Regulations of and in relation to the Ground Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules

thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This electronic record is generated by a computer system and does not require any physical or digital signatures.

- 37. Participant and/or Registrants and / or Parent/Legal Guardian of the Participant and/or Registrant(s) who do not comply with these Rules & Regulations, or who attempt to interfere with the operation of the App in any way will be disqualified and their entries may not be counted.
- 38. The Company reserves the right to disqualify Ground Contest or suspend Ground Contest if it has reasonable grounds to suspect that fraudulent activity has occurred or if it considers there has been any attempt to rig/manipulate the Ground Contest. The Company and/or Channel has the right to substitute an alternative Ground Contest method at its absolute discretion
- 39. The Parent/Legal Guardian shall not offer any bribe or make any requests to any members of the Company to get any favours. Any such acts shall eliminate the Participant and/or Registrant from Show. Any fraud in respect to entries or tampering of Ground Contest process will attract legal action and disqualification from the Show.
- 40. None of the Parent/Legal Guardian or the Participant and/or Registrant shall, without the prior written approval of the Company, speak to the press or any other media or any third person, nor give any interviews or comments relating to the Ground Contest s or any aspect of the Show or write blogs, post any messages in social networking or any site. The Parent/Legal Guardian or the Participant and/or Registrant shall not disclose any information whatsoever relating to the Company/Producer to any other party. Violation of this clause shall immediately disqualify the Participant and/or Registrant's prospects of further participation.
- 41. As part of Participant and/or Registrant' contribution to the Show, the Company may request Participant and/or Registrant(s) to participate in any online/interactive activity relating to the Show including without limitation recordings of webcasts, interviews and participation in so-called 'chat-rooms'. The Parent/Legal Guardian on behalf of Participant and/or Registrant hereby agree that the Participant and/or Registrant shall participate in any and all such marketing and promotional activities, as required by the Company and/or the Producer.
- 42. Taking part in the registration process shall be deemed to be acceptance by the Parent/ Legal Guardian(s) to receive promotional messages from the Company or any third party so authorized by the Company regarding current and future chapters of the Show.
- 43. Ground Contest will be subject to such timing stipulations and requirements as may be determined by the Company and the Company makes no representations, warranties nor provides any undertaking to any of the Participant and/or Registrant(s)

- that any or all of the Participant and/or Registrant(s) will be able to take part in Ground Contest.
- 44. The Company shall not be liable nor responsible for any damages, losses, costs, expenses or otherwise suffered by any of the Participant and/or Registrant(s) and / or Parent/Legal Guardian of the Participant and/or Registrant(s) in the event that the Company is not able to permit the Participant and/or Registrant(s) to take part in the Ground Contest or Show in accordance with any of the foregoing provisions.
- 45. The Company shall not entertain any request by the Participant and/or Registrant(s) and/or the Parent/Legal Guardian for change in the venues, dates and time of Ground Contest.
- 46. The Company may in its sole discretion exclude a Participant and/or Registrant from participating in the Ground Contest of the Show which may include without limitation (i) circumstances which, in the Company's view, renders the Participant and/or Registrant unfit to participate therein; (ii) inability to produce documentation specified by the Company proving the identity of the Participant and/or Registrant; (iii) any other reason that, at the discretion of Company, would adversely impact the Company, Channel or Show.
- 47. At no point of time will the Company/Producer be obliged to notify unsuccessful Participant and/or Registrants and / or Parent/Legal Guardian of the Participant and/or Registrant(s) of its decision.
- 48. The Company will have no liability to the Participant and/or Registrant (s)/ Parent/Legal Guardian who is unable to attend or take part in the Show for whatever reason and the Company shall be entitled to disqualify the Participant and/or Registrant(s), replace any such Participant and/or Registrant(s) from the Show at any time, at the discretion of the Company.
- 49. In the event that there is a tie between two (or more) Participant and/or Registrant(s), the Company shall be entitled to determine in its absolute discretion which Participant and/or Registrant(s) is eliminated and/or which Participant and/or Registrant(s) goes through to the next round (as appropriate) and for this purpose it shall be entitled to make such arrangements or request such further rounds from the Participant and/or Registrant(s) as it in its absolute discretion deems necessary. No enquiries, appeals, verbal or written, shall be entertained in this regard.
- 50. In the event of any fault, misunderstanding or dispute concerning any part of the Show, and/or the operation of the telephone system, Ground Contest s, call-backs, the selection of Participant and/or Registrant(s) at any stage, the decision of the Company shall be final and binding on all Participant and/or Registrant(s) and/or the Parent/Legal Guardian. The Company / Producer of the Show is empowered to take a decision on any case or instances not covered by the present Rules and Regulations.

- 51. The Company has the right at any time to terminate the Show without any prior intimation or notice to the public and also the Company is not obligated in any manner whatsoever to compensate any person or persons who have participated and/or who are participating in the Show and/or accommodate any person or persons who have been selected in the Show for the Program.
- 52. The Parent/Legal Guardian specifically agree not to file in person / through any family member and / or any third party any applications, criminal and/ or civil proceeding in any courts or forum in the Territory or outside the Territory against CMEPL/ Producer and/or their directors, process advisors and process auditors, employees, officers, affiliates or subsidiaries to claim any damages or relief of any nature in any manner in connection with the Ground Contest or the Show. However, in the event, the Parent/ Legal Guardian are found to be causing any disturbance or disruption before, during or after the Ground Contest then the Company or the Show Management shall have the right to immediately remove or disqualify the Participant and/or Registrant. The Parent/Legal Guardian hereby undertakes that the Participant and/or Registrant shall, on attaining majority, not raise any claims of any nature whatsoever against CMEPL or the Show Management in any manner and hereby agrees to keep CMEPL and the Show Management indemnified in this regard.
- 53. The Participant and/or Registrant(s) and / or Parent/Legal Guardian of the Participant and/or Registrant(s) shall comply with all the applicable laws of India. The Participant and/or Registrant(s) and / or Parent/Legal Guardian of the Participant and/or Registrant(s) shall also comply with the Rules and Regulations including the Rules & Regulations of the App.
- 54. If any provision of these Rules & Regulations is held by any court or other competent authority to be void or unenforceable in whole or part, the other provisions of these Rules & Regulations and the remainder of the affected provisions shall continue to be valid.
- 55. These Rules & Regulations and the Show / Contest shall be governed by and construed in accordance with the laws of India and the Participant and/or Registrant(s) and / or the Parent/Legal Guardian of the Participant and/or Registrant(s) submit irrevocably to the jurisdiction of the Courts in Mumbai.

Intellectual Property Rights

- 1. Participant and/or Registrant(s) and/or the Parent/Legal Guardian of the Participant and/or Registrant(s) hereby agree and irrevocably acknowledge that the Company shall have the sole and exclusive right including but not limited to intellectual property rights (copyrights and trademarks) and other proprietary rights in and to the Show, the Participant and/or Registrant's appearance and participation on the Show, the Parent's or the Legal Guardian's appearance on the Show and all its components whatsoever.
- 2. All the intellectual property rights with respect of the performance of the Participant and/or Registrant(s) either in the Ground Contest or in the Show including but not

limited to the copyright, rights of publicity, moral rights and any related rights shall stand waived and the Parent/Legal Guardian on behalf of the Participant and/or Registrant hereby agree not to claim or enforce any of the aforementioned rights in any court, tribunal or any other forum whether in India or anywhere else. The Parent/Legal Guardian on behalf of the Participant and/or Registrant also explicitly consents to the Company's right to reproduce the Participant and/or Registrant' picture or the recording provided by the Parent/Legal Guardian or portray the Participant and/or Registrant(s) in any and all media now existing or hereinafter created, including without limitation television, film, radio and print media, without any compensation whatsoever for advertising and publicity purposes of the Show or any other Show of the Company, except where prohibited by law. The Parent/Legal Guardian on behalf of the Participant and/or Registrant also consents to the Company's right to use Participant and/or Registrant(s) name, voice or picture, or the content of his/her Ground Contest without any further permission or compensation for such use in any and all media now known or in commercial use or developed based on media now known or in commercial use. The Parent/Legal Guardian on behalf of the Participant and/or Registrant grants the Company irrevocable consent in perpetuity to the use of the sound recordings, photographs, video tape, and illustrations taken during or in connection with the Ground Contess, in any and all applications including but not limited to advertising, commercials, promotion, stories, text, articles, illustrations, copy and commercial exploitation, in any and all media forms, including but not limited to radio, broadcast and television, newspapers and magazines at any time without requiring the Parent's/Legal Guardian's further knowledge or consent.

- 3. The Parent/Legal Guardian on behalf of the Participant and/or Registrant hereby agree and consent to the collection, recording, processing and storing of the Ground Contest Videos submitted and the personal interviews during the Ground round. Further, any photographs, videos, documents etc. submitted to the Company or recorded by the Company during the Ground Contest or registration procedure shall on submission / creation become the property of the Company ("Materials") and shall be available to the Company for exploitation throughout the world in perpetuity. The Parent/Legal Guardian on behalf of the Participant and/or Registrant hereby waives off all the rights that they may have with respect to such Materials. The Parent/Legal Guardian on behalf of the Participant and/or Registrant shall ensure that the photos or videos submitted by them in any public domain or their performances shall not be obscene, vulgar, defaming, denigrating women or children, hurting religious sentiments, depicting violence or shall not infringe the rights of a third person. In the event of any violation, the Participant and/or Registrant(s) shall immediately be disqualified from taking part in the Ground Contest s/Show or any further rounds of participation and such Parent/Legal Guardian of such Participant and/or Registrant(s) shall solely remain liable for any action (criminal/civil) arising therefrom.
- 4. The Parent/Legal Guardian on behalf of Participant and/or Registrant hereby grant to the Company and its affiliates/ group companies, the unfettered right to exploit exclusively and in perpetuity, the content and/or recording, and its derivatives thereof and/or any part thereof, through any and all means including but not limited to the

right to use Participant and/or Registrant's and/or Parent/Legal Guardian's name including sobriquet, photographs, images, likeness, voice, audio — visual, videos, Ground Contest videos, recording, etc. provided/ submitted by the Participant and/or Registrant and/or Parent/Legal Guardian to CMEPL and/or recorded by CMEPL or the Show Management during the Ground or the Show through all media including without limitation television, radio, print, mobile, internet, websites, mobile applications and/or any such media, technology in existence, whether now known and/or devised in the future, from time to time, for unlimited transmission in perpetuity for the territory as CMEPL may deem fit.

5.
