

Rules and Regulations for “Tamil Idol – Season 1”

“**Tamil Idol - Season 1**” (hereinafter referred to as “**Show**”) is organized and conducted by Sony Pictures Networks India Private Limited (formerly known as Culver Max Entertainment Private Limited) (“**the Company**”). The Show will be telecasted on the Company’s channel “Sony Vizha” (“**Channel**”) and hosted on the Sony LIV App (“**App**”). The Show will be governed by the rules and regulations stated hereunder (“**Rules**” or “**Rules and Regulations**”). The Company reserves the right to modify these Rules and Regulations without any prior notice. You (**‘Participant(s)’/ ‘You’/ ‘Your’**) are advised to access, view and keep themselves informed of these Rules and Regulations. If you do not agree with any of the Rules and any amendments thereto, you must not participate in the auditions of the Show.

Definitions

Company	Sony Pictures Networks India Private Limited (formerly known as Culver Max Entertainment Private Limited). The Company shall mean and include its affiliates, group companies, its employees, officers, and directors.
Show Management	Organizers of the Show including the Producer (defined below), the Company or its respective assignees and affiliates.

Sony LIV Application (App)	Application owned and controlled by the Company, which is open for the public at large within the Territory, subject to these Rules and Regulations.
Participant	Any individual who appears for the audition of the Show and completes the registration process (as described herein below) are eligible to participate in the auditions as per Rules and Regulations defined herein.
Participant Eligibility	Any person who (i) is above fourteen (14) but not above thirty (30) years of age as on 18th August 2026 (ii) is a citizen of India and residing in India (iii) is of sound mind and health (iv) does not have any criminal conviction (v) does not have any disability by way of any existing arrangement or contractual obligation which prevents the person from participating in the Show or performing in any event such as singing, music composition or any other event of similar nature organized by the Show Management (vi) enters the Show in accordance with the Rules and Regulations as stated in this document. Employees of the Company, of the Producer, of the advertising agency, of the process advisors, of the agents, of the process partners and any other person associated with the Show or the Company which has been appointed from time to time, employees of the sponsors and members of their immediate family, persons other than Indian

	nationals, or Indian nationals living outside India, or those who do not qualify under the definition of resident of India as per the Income Tax Act, 1961 or those persons who have participated and made it to any televised rounds of any previous seasons of the Show or any other show of similar nature are ineligible to enter the Show. <i>Note: For Participants who are under 18 years of age (“Minor”) all the Rules & Regulations stated herein shall deem to apply on the Parent/Legal Guardian (as defined hereinafter) of the Minor and the Parent/ Legal Guardian of the Minor Participant shall be bound by all the Rules & Regulations on behalf of the Minor at all times. Upon reaching the age of 18 years within the duration of the Show, all the Rules & Regulations shall be applicable to such grown minor as that to the other participant.</i>
Auditionee	Shortlisted Participant who participates in the Mega Audition Round, from whom the Contestants for the Show shall be selected, as per sole discretion of the Company.
Contestant	Participants selected to appear on the Show
Mega Audition	Shall mean and includes the Level 1 Audition (Bus Audition, Online Audition and Walk-in Auditions), Level 2 Audition and, Level 3 and 4 Audition, as specified below.
Audition(s)	A. ‘Level 1 Audition’ - The first stage of the audition process, comprising the three parts set out below, which shall be conducted in such manner and at such time(s) as may be determined by Show Management at its sole discretion. i. ‘Bus Audition’ - On-ground auditions conducted wherein the audition bus shall travel to various cities as may be determined by the Show Management at its sole discretion, and Participants may approach the audition bus, complete the physical registration form and perform to audition at the bus location. ii. ‘Online Audition’ - Audition conducted online, wherein Participants shall access the Sony LIV Application, complete the online registration form and upload up to three (3) audition videos in accordance with the instructions provided therein. iii. ‘Walk-in Audition’ - On-ground audition conducted in various cities, wherein Participants may walk in, complete the physical registration form and perform before the audition panel at the applicable audition venue. B. ‘Level 2 Audition’ - On-ground auditions in which Participants shortlisted from the Level 1 Auditions shall perform before the music coaches and creative team from the Show Management.

	The Level 2 Audition shall be conducted at Chennai, Trichy, Coimbatore and Madurai, or at such other location(s) as may be determined by the Show Management, at its sole discretion. C. 'Level 3 and 4 Audition' - On-ground auditions in which Participants shortlisted from the Level 2 Auditions shall be called to Chennai, or such other location as may be determined by the Show Management, to perform before the music coaches, channel and the creative team, as per the discretion of the Show Management.

Rules and Regulations	Rules governing the Show, stated herein in entirety, as may be amended from time to time by the Company, in its sole discretion.
Territory	India
Audition Period	The Audition period for the Auditions which shall start from 18 th August 2026.
Social Media Platforms	Facebook and Instagram
Parent	For the purpose of participation in the Audition, it is hereby clarified that Parent shall mean the natural parent of the Participant being his or her biological Father or Mother and shall include persons who take the legal responsibilities of the child as parents on account of adoption or as foster parents. In either case, the relationship shall have to be established by way of proper documentation and Company shall have the sole discretion to decide about allowing such Participants.
Legal Guardian	Legal Guardian shall mean such guardian as appointed by a District Court under the relevant provisions of the Guardians and Wards Act, 1890. Any other claim for Guardianship shall have to be established by way of proper documentation and Company shall have the sole discretion to decide about allowing such Participants.

Procedure to participate in the Show

1. The Show is open for all eligible Participants as defined hereinabove in this document.
2. The Auditions will be conducted offline/on-ground and/or online, and interested Participants are required to submit a fully filled registration form. The registration form can be filled and submitted in one of the following ways:
 - a. **Bus Audition Process:** Participants desirous of participating in the Bus Auditions through the mobile Audition Vehicle can follow the process as set out below:
 - i. A bus/van or other mobile vehicle (“Audition Vehicle”) shall travel to such cities and locations as may be determined by the Show Management from time to time, at its sole discretion, for the purpose of conducting the Bus Auditions.
 - ii. The Audition Vehicle may stop at multiple locations in the relevant cities, and Participants may approach the same during the applicable audition timings.
 - iii. Participants shall be required to complete the physical registration form and such additional information as may be required by the Show Management, as set out above.
 - iv. Upon completion of the registration process, the Participant shall be required to perform before the audition panel.
 - v. The performance by the Participant in-person shall not involve the use of any pre-recorded audio, video or vocals that may affect or enhance the Participant’s performance.
 - b. **Online Audition Process:** Participants desirous of participating in the Online Auditions through the Sony LIV Application can follow the process as set out below:
 - i. Participants who are not registered users of Sony LIV Application shall be required to register by entering a valid mobile number. Participants would then be required to verify their mobile number by entering the One-Time Password (OTP) received on mobile number. Upon successful verification of the One-Time Password (OTP) received on such mobile number, the Participant can click on the Show banner to access the Registration Form. Participants who are already registered users of Sony LIV Application may access the registration form available on the Sony LIV Application.
 - ii. Participants shall provide the basic personal and such additional information as may be required for registration, which may be subject to change at the sole discretion of the Show Management.
 - iii. Participants may upload up to three (3) video recordings, each featuring a performance in a different genre and having a minimum duration of ninety (90) seconds.

- iv. Participants shall ensure that the Audition video is recorded in a well-lit environment such that the Participant's face is clearly visible throughout the recording. The Participant shall ensure that the device used for recording has a functioning camera and microphone, that the audio and video are clear and audible/visible, and that the camera remains steady and does not shake or move during recording.
 - v. Participants shall also ensure that they have a stable internet connection for uploading the audition video and that the video is recorded and uploaded in the format, size and duration specified by the Show Management.
 - vi. Participants shall be solely responsible for ensuring the quality, completeness and successful upload of the Audition video. The Show Management shall not be responsible for any failure or inability to record or upload the Audition video arising from any device, network, connectivity or other technical issues at the Participant's end.
 - vii. In the event a Participant is unable to upload an Audition video, the Participant may reduce the file size and attempt to upload the video again, subject to the applicable file size and format requirements.
 - viii. A Participant shall not be permitted to proceed with the Online Audition unless such Participant has accepted these Rules and Regulations and consented to the collection, processing and storage of their personal information for the purposes of the Show.
 - ix. The Audition video uploaded by the Participant shall be an original recording of the Participant and shall not be AI-generated, digitally manipulated, altered or otherwise edited in a manner that misrepresents the Participant's actual performance. Submission of any AI-generated or materially manipulated video may, at the sole discretion of the Show Management, result in disqualification of the Participant from the Audition process.
- c. **Walk-in Audition Process:** Participants who have not participated in the Bus Audition or the Online Audition may participate in the Walk-in Auditions conducted in various cities as may be determined by the Show Management at its sole discretion by following the process below:
- i. Participants may visit the Walk-in Audition location on such date(s) and time(s) as may be determined by the Show Management.
 - ii. Participants shall be required to complete the physical registration form and provide the basic personal and such additional information as may be required by the Show Management, as set out above.
 - iii. Upon completion of the registration process, Participants shall perform in-person before the audition panel.
3. Participants selected at the Level 1 Audition shall be eligible to participate in the Level 2 Audition, which shall be conducted as an on-ground audition in four (4) cities, as set out below, wherein such Participants shall be required to perform before the Show Management.

Participants selected at the Level 2 Audition shall be shortlisted for participation in the Level 3 and Level 4 Auditions. Such Participants shall be informed of their shortlisting either at the venue of the Level 2 Audition or subsequently contacted by the Show Management, as may be applicable, The Level 3 and Level 4 Auditions shall be conducted in Chennai. Participants shortlisted at the Level 3 and Level 4 Auditions shall be selected to participate in the Show as Contestants, subject to the sole discretion of the Show Management and the applicable Rules and Regulations of the Show.

On completion of the registration the Participant or Parent/Guardian in case of a Minor in any stage of the audition(s) of the Show, by virtue the Participant/Parent/Guardian accepts and agrees to these Rules and Regulations to enable the Participant to participate in the Auditions in addition to the Terms & Conditions put on the website www.SonyLIV.com and further to be bound by any decisions made by the Show Management.

4. In cases of participation of a Minor, the Parent or Legal Guardian of the Minor participating in the Audition hereby represents and confirms that such Parent or Legal Guardian completely understands the nature of Show and that he/she has voluntarily chosen at his/her free will to permit his/her Minor child to participate in the Auditions and further participate in the Show (if selected) and such Parent or Legal Guardian (in case of Minor Participant) is willing to bear all risks, costs & consequences arising from participation of his/her Minor child in the Audition and/or the Show. All representations and warranties, obligations, terms and covenants as laid down herein and applicable to the Minor Participant shall be deemed to be applicable to the Parent/ Legal Guardian and the Parent/ Legal Guardian (in case of Minor Participant) hereby agrees to comply and abide by the same.
5. The Parent/ Legal Guardian (in case of Minor Participant) hereby agrees and acknowledges that it shall be such Parent's/ Legal Guardian's complete responsibility in case of Minor Participants to ensure that the Minor's school/ college / university/ institute's attendance and education is not affected due to his/ her Minor child's participation in the Audition/ subsequent Auditions and/or Show (if selected). The Parent/ Legal Guardian (in case of Minor Participant) hereby undertakes to be fully responsible towards Minor Participant's education and shall ensure that the Minor Child's education & welfare will not be affected in any manner while permitting him/her to participate in the Auditions, subsequent round of Auditions and/or Show.
6. The Participant and/or Parent/Legal Guardian (in case of Minor Participant) hereby agrees and confirms that even if the Participant is selected for the Auditions and/or the Show, neither the Participant nor the Parent/ Legal Guardian (in case of Minor Participant) shall have any right to claim any benefit/demand/consideration/monies from the Company, Producer or the Show Management, in addition and/or in exchange of the selection.

7. Any incomplete, erroneous, or unclear information shall be considered invalid and deemed null and void and the entry of such Participant will not be considered.
8. By participating in the Audition and/or the Show, the Participant(s) agrees to be bound by any decisions made by the Show Management in its sole discretion, including any interpretations of the Rules and Regulations.
9. In order to confirm the eligibility of the Participant(s), the age of the Participant(s) shall be verified at the Level 1 Audition against a valid age proof document (details of age proof given below) produced by the Participant(s) for verification. At the Level 3 Audition, shortlisted Participant(s) mandatorily require submitting scanned copies of all the following documents as and when asked for by the Company. The Company has the right at any time to require proof of identity and/or eligibility. Failure to provide such proof within a reasonable time could result in disqualification from the Show. If the Participant(s) are found to be ineligible, or if they have not complied with these Rules and Regulations, will be disqualified:
 - i. For valid Identity Proof (any one of the following):
 - i. PAN Card
 - ii. Aadhaar Card
 - iii. Driving License
 - iv. Passport
 - v. Voter Identity Card
 - ii. For valid Age Proof (any one of the following):
 - i. Passport
 - ii. Birth Certificate
 - iii. School Certificate
 - iv. Court Affidavit
 - v. Aadhaar Card
 - iii. For valid Address Proof (any one of the following):
 - i. Passport
 - ii. Ration Card
 - iii. Driving License
 - iv. Electricity Bill
 - v. Aadhaar Card
 - iv. For valid Proof of relationship/guardianship (any one of the following):
 - i. Ration Card
 - ii. Passport
 - iii. Birth certificate
 - iv. PAN Card
 - v. Court order declaring the Guardian as the legal guardian of the Minor Participant
 - vi. Any other Govt. document establishing the relationship/guardianship

(Submission of the aforesaid documents does not imply that the Participant has been selected for further participation)

10. Documents provided should be clear, readable scanned copies and any failure to provide the same can lead to disqualification. The Company reserves the right to disqualify any Participant(s) from the Show or the Audition, in its sole discretion, if the Company is not satisfied with the documents submitted by the Participant and/or the Parent or Legal Guardian (in case of Minor Participant) or the Participant(s) at any stage is unable to supply any of the documents required by the Show Management/ the Company or supplies unclear, inaccurate, incomplete, or misleading personal details and/or information.
11. Participant(s) are required to adhere to the verification process of the Company at the designated location which inter alia includes bringing original copies of their age proof, residence proof and their nationality proof ("**Documents**"). Additionally, the Legal Guardian(s) shall be required to provide the Company and/or the production house requisite documentation i.e., original copy of passport, birth certificate or PAN Card, evidencing the relationship with the Participant(s) in case the Participant is a Minor and any necessary further documentation in relation to Minor's participation including but not limited to school leaving certificate. Successful verification of the documents is mandatory for the Participants to progress further towards the Mega Auditions. The Company reserves the right to ask the Participant to re- submit any of the above-mentioned document proof at any stage of the Show at its sole discretion.
12. In case, any Participant is not able to furnish the required documents to enable such participation, the Company shall have the sole discretion to decide whether or not such Participants can participate or continue with their participation in the Auditions and/or show.
13. Where applicable, the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) shall be required to, at all times and at the Participant's and/or the Parent's and/or Legal Guardian's sole cost, obtain and maintain the requisite visas, approvals, permissions etc. (for the Participant and any companions) for stay in India, working in India and performance and participation of the Participant in the Show in India. The Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) shall also be solely responsible to obtain all permissions that may be required from relevant authorities, at the Participant's and/or the Parent's and/or Legal Guardian's sole cost, for the Participant to stay in India and to participate in the Show. The Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agree that the Company shall in no event, whatsoever, be responsible for or required to help or make any submissions on behalf of the Participant(s) with respect to any visa documentation during or in relation to the Participant's participation in the Auditions and/or in the Show including but not limited to travelling anywhere and anytime and undertaking the performances required for the Show. The Company shall have the sole discretion to disqualify or eliminate any Participant, at any stage, should the Participant fail to obtain or maintain required visas or other permissions for the Participant to be able to participate in the Show. The Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) and their companions shall at all times be solely responsible for compliance with any and all applicable laws, rules and regulations with respect to their stay in India, any immigrations requirements, COVID protocols in India or their home country or in relation to their participation in the Auditions and/or the Show.
14. In the event that there is a tie between two (or more) Participant(s), the Company shall be entitled to determine in its absolute discretion which Participant(s) is eliminated and/or which

Participant(s) goes through to the next round (as appropriate) and for this purpose it shall be entitled to make such arrangements or request such further rounds from the Participant(s) as it in its absolute discretion deems necessary. No enquiries, appeals, verbal or written, shall be entertained in this regard.

15. The Participant(s) will not be levied any charges to participate in the Auditions or to upload digital audition video via any of the means provided herein, however, the network provider may levy data and other charges to the Participant, at the applicable rate for using internet connection. It should be verified by the Participant at his/her sole responsibility. In case of uploading videos while roaming in different circle/zone, additional roaming rates for browsing the internet may be applicable. The Company shall not be responsible for any such charges incurred by the Participant. For further details, please contact your service provider
16. The process by which the shortlisted Participants are informed of their selection will be updated by the Company by the way of updating these Rules and Regulations. The Participants are advised to regularly access, view, and keep themselves informed of these Rules and Regulations.
17. Participants will be allowed to audition only once; any re-entry would be automatically disqualified. At all times, Participants must agree that the decisions of the Show Management shall be final and binding on themselves and they shall not have any claim against such decisions taken by the Show Management in respect of the Audition and the Show.
18. The Company reserves the unconditional right to disqualify any Participant on any grounds as deemed fit for the successful execution of the Show.
19. The Participant/ Legal Guardian on behalf of Minor Participant shall undertake, warrant, and guarantee to the Company that he/she has full legal capacity to participate in the Show in accordance with these Rules & Regulations.
20. It is a condition of entry and participation in the Show that Participant(s) and/or Parent/ Legal Guardian on behalf of a Minor participant, agree and sign up or acknowledge the Participant Release Form and any other documents as requested by the Company/Producer and abide by Rules & Regulations of such Participant Release Form and the Rules, Regulations as devised from time to time by the Company including but not by way of limitation of these Rules & Regulations. Participants and/or Parent/ Legal Guardian on behalf of a Minor shall sign and execute all documents and agreements as required by the Show Management to enable the Participants to participate in the Audition and/or the Show.
21. The Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agree that the Participant has no disability which would prevent the Participant's participation in the Show or any other incidental event conducted by the Show Management.
22. The Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) acknowledge that the Participant has voluntarily chosen to participate in the Show at the Participant's free will and is willing to bear all risks, costs, and consequences arising from such participation. It is a condition of entry and participation in the Show that:

- a) the Participant does not have any valid and existing contractual, commercial, sponsorship agreement (including but not restricted to singing, music composition, recording, performing, merchandising contracts and /or any other event of similar nature) and /or
 - b) the Participant does not have any other arrangements for e.g. with a management company or an individual to act as the Participant's manager in respect of his/her musical or performing abilities or the products thereof or in respect of his/her name, likeness, image or biography which might be in breach of the Release Form or Rules and Regulations or otherwise prevent the participants from participating in the Show or the broadcast, promotion, exploitation, or sponsorship thereof.
23. Participants should participate on their own and not on behalf of anyone else. In case of Minor, i.e., Participant who has not attained the age of majority i.e. 18 years or above as per the Income Tax Act, 1961 all the legal formalities are to be completed by their Parent/Legal Guardian on behalf of Participants.
24. Employees, officers, directors, agents, and promoters including their immediate family members; of the Company and its affiliates across the globe, sponsors, producers, advertising agency, process advisors and evaluators, contract employees/ staff, partners, their affiliates, subsidiaries, group companies in India are not eligible to participate in the Show.
25. Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) hereby represent and warrant that Participant(s) is not under any disability, restriction, or any kind of prohibition, which shall prevent Participant from performing or adhering to any of the Rules and Regulations herein and have not entered into and shall not enter into any agreement that may violate the Rules and Regulations herein.
26. By registering for the Show, the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) represents that the Participant is medically fit and do not have present or past psychological ailments at the time of Audition, any subsequent rounds of Audition and/or during the Show. If, in the past, the Participant has had any psychological ailments or have been under medication for any psychological anxiety, hypertension, depression or any other medical problems, the same shall be disclosed to the Show Management in writing along with a copy of the certificate from a qualified medical practitioner declaring the Participant to be fit for participation in the Show. However, in the event such medical conditions render the Participant(s) unfit for participation in the Show, then the Show Management shall have the right to disqualify such Participant(s) from further participation. If such Participant(s) has won any prize money before any such disability, then the same shall be paid to the Participant(s) in accordance with the process communicated by the Show Management.
27. If at any point in time during the Audition, any subsequent rounds of audition and/or the Show, it comes to the Company's knowledge that the Participant has become medically/mentally/physically unfit to continue with the participation in the Audition and/or the Show, then the

Company or the Show Management reserves all the rights to disqualify /eliminate the Participant from the next round of Audition or Show and/or at any point in time, without any liability to the Participant and/or Parent/ Legal Guardian (in case of Minor Participant).

28. The Company may, at its discretion, contact the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant), if required, for any clarifications needed for the information provided in the registration. The Participant(s) may be disqualified from further participation in the Show, if Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) is unable to give appropriate clarification as deemed fit by the Company.
29. In case there is any mismatch of Participant(s) details in any round of the Show, the Participant(s) may be disqualified from further participation in the Show, if Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) is unable to resolve discrepancies.
30. On providing the mobile number for registration, the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) expressly consent for the Company to send SMS/RCS to or call the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant), whether or not such the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) is registered on the National Do Not Call registry. The Company/ Producer may, at their discretion contact the Participants and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant), if required, for any clarifications needed for the information provided in the registration form. All personal details and information requested by and supplied to the Company by each Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) must be true, accurate and in no way misleading. In case, it is found that the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) has provided any incorrect/ false details knowingly or unknowingly, the Participant shall be disqualified from further participation in the Show.
31. On request of the Company, the Participant(s) the Parents and/or Legal Guardians (on behalf of the Minor Participant) shall make arrangements for the Company to have access including but not limited to the Participant's residence, workplace, favorite hangouts, pets, etc. and obtain necessary permissions from the Participant's parents, siblings, friends, colleagues and any other relevant persons to be photographed, interviewed and to record or click their photographs, videos etc. if this is a creative requirement of the Show.
32. Whilst the Company shall make all reasonable endeavors to (i) enable Participants(s) to proceed with the Show (ii) to contact all Participants(s) the Parents and/or Legal Guardians (on behalf of the Minor Participant) at each relevant juncture of the Show, in the event the Company or the Show Management is unable to successfully reach/contact or communicated with the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant), the Company shall, in its sole discretion, be entitled to proceed with the next eligible Participant(s) under these Rules and Regulations.
33. Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor

Participant) warrants and represents to the Company that all information, including any communications, photos, text, video, graphics, images and other material submitted by the Participant for the Show and in relation to the Show (“**Content**”), are solely owned by the Participant or are provided with the express authority of the applicable owner(s) and the use of the Content by the Company will not infringe upon any other individual or organizational rights (including, without limitation, intellectual property rights). Participants and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agree to participate in the Show at their own will and the Show Management, the Company are not in any way obligated or liable for any loss or costs that the Participant may suffer or incur and nothing is payable to the Participant for participating in the Show or the events following the Show’s broadcast/streaming.
35. The Show Management reserves the right to, at its sole discretion, withdraw or amend or add to these Rules / format of the Show at any time, with prospective or retrospective effect, and does not take responsibility for any loss or damage that any Participant may suffer as a result of participating or attempting to participate in the Show, the Show being withdrawn, or the Rules / format being amended.
36. Using of false names/ identities, illegal/false mobile numbers, fake email addresses, Social Media Accounts and/or any other illegal means either online or in hard copies shall be considered as suppression of facts and if the company has to suffer of any adverse consequence in this respect, the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) shall be disqualified and penalized for the same in any manner as the Company may deem fit.
37. Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) found indulging in any malpractices including but not limited to cheating, misrepresentation, providing false information shall be disqualified from the on-going Show and strict legal action may be taken by the Company against such Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant).
38. In the event any Auditionee and/or Participant(s) (including winner) is found to be in violation of any rules of the Show, these Rules and Regulations or is found to be involved in any form of fraud, misrepresentation, dishonesty during the Show, the Show Management reserves the right to initiate legal proceedings against such Auditionee and take any other action in its sole discretion including but not limited to recovering the prize money or any expenses it may have incurred towards that Auditionee.
39. The decision of the Company on all matters, queries, or disputes, concerning the Show

including the selection of Participants for the Auditions, the number of rounds of Auditions conducted, the criteria for selection for further rounds of Auditions and/or Show, the format of the Show, the selection of the Winner(s) and the Rules and Regulations shall be final and binding and no correspondence shall be entertained in this regard.

40. 41. With respect to prize money, any withholding requirements will be complied with. Taxation of any proceeds should be discussed with your tax advisor. Taxes on the prizes are the sole responsibility of the prize winners.
42. The Participant agrees that participation in any stage of the Show (including audition) shall not entitle the Participation to participate in any subsequent stage. The Company reserves its right to disqualify and/or exclude, in its sole and absolute discretion, any participant from any stage of the Show without assigning any reason, therefore.
43. The Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) represent that the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) are in no way connected/related to the Company, Producer, its subsidiary or affiliates or any group companies. Participation by anyone shall be rejected, if it is found that the Participant is related to the Company and/or Show Management in any way as mentioned herein above.
44. Participants and/or the Parent/Legal Guardian (on behalf of Minor Participant) shall not offer any bribe or make any gesture towards any ground management team and/or any members of the Company to get any favors. Any such acts shall eliminate the Participant from Show. Any fraud in respect to entry forms and/or any other documents and/or tampering of audition process will attract legal action and disqualification from the Show.
45. Participants shall not harm or damage any resources/material/property on set.
46. Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agrees to follow all directions/rules and regulations framed or given by the Company from time to time in connection with the audition and the Show. The Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agrees that the Participant's participation is of voluntary in nature and by Participant's own risk and will have no claim against the Company on any account whatsoever. The Company shall not be responsible for any damage, loss or any form of physical or mental harm or injury caused to the Participant and/or the Parents and/or Legal Guardians of the Minor Participant.
47. For the purpose of participation, all expenses if any, including travelling and lodging cost and expense incurred in sending SMS shall be borne by the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant). This clause is applicable to the

participant and anybody accompanying the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) as well.

48. The Company shall not be responsible to the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) and/or winner for cancellation, discontinuance and/or postponement of the audition or the Show. The Participant(s) the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agree and undertake that the Participant is not entitled to any cash equivalent or alternatives for participation in the Show.

50. The non-adherence of the signed documents will lead to disqualification, as deemed fit by the Company.

13. The Company reserves the right to suspend any of the Participant(s) in case it has reasonable grounds to conclude that the Participant(s) and/or the Parent/Legal Guardian (in case of Minor Participant) have been alleged in any public domain and/or social media websites for any misconduct, sexual harassment, physical abuse, coercion in any form, criminal cases or any other reasons which may be tantamount to general misconduct.
14. The Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant)

shall ensure that the acts/ performance in the Online Audition Video and/or other Auditions shall in no manner infringe any rights including the copyright of a third person/party. In the event of any violation to the aforementioned, the Participant shall be disqualified from the Audition(s), immediately, without any prior notice of the same and the Parent/ Legal Guardian (on behalf of Minor Participant) shall solely be liable for any and all action arising therefrom and shall also be liable to indemnify the Company, its affiliates/group companies/employees, the Producer, agents, representatives, etc. against any and all losses, claims including third party claims, disputes, disruption, demands, actions, damages, liabilities, etc.

15. The Contestant and/or Participant hereby agree that by participating in the audition(s) for the Show, shall not without the prior consent of the Company, appear in any other television programme or singing shows or film or web-series or commercials until the end of the broadcast of the Show.
16. Participant(s) will not be confirmed as Contestants of the Show if they are suffering from any kind of ill health, medical problems including but not limited to heart ailment, blood pressure ailment, final stages of pregnancy, COVID-19 etc. It is the responsibility of the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) to be medically fit for participation. Nevertheless, the final decision regarding their participation in the Studio Part of the Show rests entirely with the Show Management.
17. The Show Management shall at its own discretion make or refuse to make additional attempts to contact any Participant and/or Parent/Legal Guardian (on behalf of Minor Participant) .
20. In case of any scheduled in-person interview with the Show Management and/or Judges, only the authorized parties (including Judges, Participants, Parent/Legal Guardian (of Minor Participant) the Company, Producer and their representatives) will be allowed into the interview venue. The Company will have the final right to refuse registration/ eligibility/entry at their sole discretion.
21. The Show Management reserve the right to record the personal interview as part of the selection process and for future reference. However, the Participant and/or Parent/Legal Guardian (on behalf of Minor Participant) cannot record the Personal Interview. In the event of any unforeseen loss of recordings, the Company may, at its own discretion, request Participants to appear for a repeat personal interview session. 22. In case of any dispute or difference in respect of this Audition, the decision of the Company shall be final & binding on all concerned.
25. Further, the Show Management shall be entitled to, at its discretion, any time during the telecast of the Show, to re-introduce the eliminated Contestants/Participant(s) and/or re-introduce fresh Individuals/Contestants/Participants during any stage of the Show.
26. The Company reserves the right to terminate and/or postpone the Show without giving any prior notice and/or reason to the Participant(s) and Parent/Guardian (of the Minor Participant). Such decision shall be final and binding on the Participant(s) and the same shall not be disputed and/or challenged in a court of law.
27. The Company reserves the right, at its sole discretion, to disqualify any Participant who may be responsible or who tampers with the entry(ies), Auditions process, and to cancel, modify or terminate the Audition or any part of the Audition/Show. Further, the Company reserves the right to take legal action against such Participant/Parent/Legal Guardian/person/party who has committed a breach under the Cyber laws (Information Technology Act, 2000 and all its amendments thereof) and/or any other laws as may be applicable from time to time and the Company shall be entitled to such remedies in law as applicable.
28. 29. The Company and its sub-contractors shall not be responsible for any delay in receipt or non-receipt or incomplete receipt of the Online Audition Video / other details of the Participant. The Company shall not be responsible for any technical difficulties or data corruption that may arise during recording/upload of the Online Audition Video/content. Further, The Company shall not be responsible and/or liable in any manner whatsoever in case the Participants and/or Parent/Legal Guardian (of the Minor Participant) are unable to register their entry and participate in the Online Auditions due to failure on part of the internet service provider, facility provider, etc.

30. 31. While all attempts will be made to protect all data from loss and/or corruption, Participant(s) and/or the Parent/Legal Guardian (on behalf of Minor Participant) hereby agree and acknowledge that all systems are prone to failure and hacking attempts. In the event of any data loss, the Company shall make reasonable endeavors and may disqualify all the Auditions received or conduct a re-Auditioning or continue with whatever data available in the manner it deems fit. The Company will not be responsible for any damage resulting from the loss of data or action taken by the Company on account of the same. The Company shall not be responsible or liable to make good any loss or dissatisfaction suffered by the Participant(s) and/or the Parent/Legal Guardian (on behalf of Minor Participant) on account of such loss.
32. The Company and its affiliates are not responsible for lost, late, illegible, incomplete, invalid, unintelligible, technically corrupted or misdirected videos, which will be disqualified. Show Management shall attempt to use commercially reasonable efforts to ensure the security and accuracy of all videos (provided, however, that Participants acknowledge and agree that such methodologies are not infallible, and that the organizers make no guarantee as to their effectiveness).

34. 37. The Show Management reserves the right, in its sole discretion, at any time and at any stage of the judging process, to reject or disqualify any Participant who is deemed ineligible or for any reason that the Show Management feels is necessary and/or appropriate, including without limitation, if that Participant has not complied with these Rules & Regulations of the Show, the Show Management determines the Participant is attempting to undermine the legitimate operation of the Show by cheating, deception, or any other unfair practices or intending to annoy, abuse, threaten or harass any other Participant or the Show Management, the Selection Panel, Jury or has interfered, in Show Management’s sole opinion, with the proper conduct of the Show.
38. Participants who do not comply with these Rules & Regulations will be disqualified and their entries may not be counted.
39. The Company reserves the right to disqualify Audition or suspend Audition if it has reasonable grounds to suspect that fraudulent activity has occurred or if it considers there has been any attempt to rig/manipulate the Audition. the Company has the right to substitute an alternative Audition method at its absolute discretion.
40. Auditions will be subject to such timing stipulations and requirements as may be determined by the Company and the Company makes no representations, warranties nor provides any undertaking to any of the Participant(s) and/or the Parent/Legal Guardian (on behalf of Minor Participant) that any or all of the Participant(s) will be able to take part in Audition. Changes may be made to the auditions schedule/timelines/phases as deemed fit by Company.

42. The Company shall not entertain any request by the Participant(s) and/or the Parent/Legal Guardian for change in the dates and time of Audition.
43. The Company may in its sole discretion exclude a Participant from participating in the Audition of the Show which may include without limitation (i) circumstances which, in the Company's view, renders the Participant unfit to participate therein; (ii) inability to produce documentation specified by the Company proving the identity of the Participant; (iii) any other reason that, at the discretion of Company, would adversely impact the Company or Show.
44. At no point of time will the Company/Producer be obliged to notify unsuccessful Participants of its decision.
45. The Company will have no liability to a Participant(s) and/or the Parent/Legal Guardian (in case of Minor Participant) who is unable to attend or take part in the Show for whatever reason and the Company shall be entitled to disqualify the Participant(s), replace any such Participant(s) from the Show at any time, at the discretion of the Company.
46. In the event of any fault, misunderstanding or dispute concerning any part of the Show, and/or the operation of the telephone system, Auditions, call-backs, the selection of Participant(s) at any stage, the decision of the Company shall be final and binding on all Participant(s) and/or the Parent/Legal Guardian. The Company / Producer of the Show is empowered to take a decision on any case or instances not covered by the present Rules and Regulations.
47. The Company has the right at any time to terminate the Show without any prior intimation or notice to the public and also the Company is not obligated in any manner whatsoever to compensate any person or persons who have participated and/or who are participating in the Show and/or accommodate any person or persons who have been selected in the Show.
48. The Company, the Producer, judges, the host, the advertising agencies, the sub-contractors used by Company for the Show, and any person or entity connected with the production (including the format owners and the broadcasters of the Show), administration or judging of the Auditions, the Show (the "**Relevant Parties**") shall be under no liability whatsoever to the and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant), in respect of any loss, damage suffered by the and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) arising from or pursuant to the Show or for any and all loss, damage, cost, expense or injury to life or property sustained by the Participant(s) at any stage of the Show and during production thereof whether or not caused by (1) the administration (including scheduling) of the Show including any failure of transportation or inability for any reason to appear for the On-ground Audition/before the judges; (2) the Participant's or any third party's participation in the Audition, or being selected

or disqualified; (3) as a result of the decisions of the judges or Company; (4) as a result of any comment, remark, judgment, view, criticism, critique, opinion and/or observation made and/or passed by the host and/or Company; and/or (5) any printing, typographical or technological errors in any materials associated with the Competition. Notwithstanding the generality of the foregoing, the relevant parties expressly exclude liability for all direct, indirect and consequential loss or damage, including but not limited to loss or damage to property or for loss of profit, business, revenue, goodwill or anticipated savings pursuant to the Show. In no event will the measure of damages include, nor will the relevant parties be liable for, any amounts for indirect, incidental, consequential, or punitive damages of any party, including third parties; or for damages attributable to the Participation(s); or circumstances beyond the relevant parties including the Producer's reasonable control.

5. The Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) to the extent permissible in law, shall not in any circumstances make any claims against the Company, the Producers, their divisions, their subsidiaries, their employees, their respective agents and representatives, directors and its affiliates arising out of or relating to any and all costs, injuries, for any kind of losses, damages, costs or injuries of any kind, including due to any problems caused by technical disruption and/or failure, server problems or any other difficulties.
6. The Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) specifically agrees and acknowledges that any disputes or claims shall be resolved individually and the Participant and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) agrees to not file by resort to any form of class action and/or through any family member and/or third party applications, criminal and/or civil proceedings in any courts or forums against the Company and/or the Producer, their directors, employees, officers, affiliates or subsidiaries to claim any damages. Under no circumstances will the Company and/or the Company entities be liable for any consequential, indirect, special punitive, or incidental damages or lost profits, whether direct or indirect, arising in any way whether in contract, tort (including negligence) or otherwise.
7. By participating in the Audition, to the extent permissible under law it shall be construed that the Participant(s) and/or the Parents and/or Legal Guardians (on behalf of the Minor Participant) has hereby expressly or irrevocably waived his/her right to raise any dispute with regard to the Show or attempt to restrain or injunct or enjoin, the development, production or exploitation of the Show and/or the continuance of the Audition.
8. The Company, shall be under no liability whatsoever to the Participants and/or Guardians, in respect of any loss, damage suffered by the Participant and/or Guardians arising from or pursuant to the Show or for any and all loss, damage, cost, expense or injury to life or property sustained by the Participant and/or Guardians at any stage of the Show whether or not caused (1) by the Participant's participation in the Show, or being selected or disqualified including loss of opportunity, loss of earnings, employment or otherwise caused to the Participant and arising as a result of his/her participation in the Show, if selected; (2) as a result of the decisions of the Company;

(3) as a result of any comment, remark, judgment, view, criticism, critique, opinion and/or observation made and/or passed by the Company; (4) by any printing, typographical or technological errors in any materials associated with the Show and/or (5) while travelling for the purpose of the Show. Notwithstanding the generality of the foregoing, the Company expressly excludes liability for all direct, indirect and consequential loss or damage, including but not limited to loss or damage to property or for loss of profit, business, revenue, goodwill or anticipated savings pursuant to participation in the activity. In no event will the measure of damages include, nor will the Company be liable for, any amounts for indirect, incidental, consequential, or punitive damages of any party, including third parties; or for damages attributable to the Participant and/or Guardian; or circumstances beyond the Company's reasonable control.

9. Neither the Company nor any of its affiliates or group companies shall be liable for any damage or loss (including but not limited to indirect, punitive or consequential loss) arising from personal injury or death, or loss of, or damage to property, which is suffered or sustained in connection with the participation herein or any aspect of the Show and further neither the Company nor any of its affiliates or group companies shall be responsible for any consumer grievances with respect the participation for the Show.
10. The Company shall not be responsible or liable in any manner whatsoever for any incident or accident that may occur during the course of the Participant's travel to or from the venue of the On-ground Auditions or the Show.

The Rules and Regulations have been originally written in English. In case of any conflict in the interpretation of the clauses between any translated language (i.e.: Tamil), the interpretation of the English rules and regulations shall prevail.
